Commissioner Shaheen gave comments with thanks to the Auditor's office for outlining the software's benefits to his department. Because other departments such as purchasing and budget, will be affected by the implementation he would like to hear from them as well. Monika Arris, Budget, came forward to comment on the benefits her department will receive from the software, many of which are the same as outlined by the County Auditor. A brief discussion followed.

Commissioner Shaheen questioned an allowance of \$300,000 for travel. Caren Skipworth, Information Technology, addressed the questions saying the vendor was located in Florida, so the teams will be flying back and forth. They are going to schedule them for three days here and two back at home; similar to the CIJS (County Integrated Justice System) project. This will be an 18 month implementation project. Commissioner Shaheen suggested looking in the Dallas area for I.T. professionals that can help with the implementation rather than allocate so much to travel.

Commissioner Shaheen questioned the cost of the implementation and the need for consultants. Ms. Skipworth explained the consultants were needed to configure the system. Additional discussion by Commissioner Shaheen with recommendations for requiring electronic invoicing in the future. Motion to approve implementation. (Time 9:51 a.m.)

GENERAL DISCUSSION

5. <u>Al-33018</u> Collin County Intermodal Hub Feasibility Study presented by the North Central Texas Council of Governments (NCTCOG), Commissioner, Precinct 2.

Commissioner Hoagland gave comments to the Court regarding the study. Ruben Delgado, Engineering, introduced Becky Karasko, Senior Transportation Planner, NCTCOG (North Central Texas Council of Governments) who presented the study. Ms. Karasko began with a brief background of the study which began in October 2009. Study partners included Collin County, NETEX (North Texas Rural Rail District) and the NCTCOG. The purpose of the study was to determine if a need existed for a third regional intermodal logistics hub.

Ms. Karasko explained the meaning of a logistics hub which is a freight facility that typically contains a Class I railroad hub, yard or terminal, manufacturing and distribution facilities, truck yard movements, office/retail development, a minimum of 2,500 acres and no less than 10,000 feet of track on a tangent within the site.

Five study areas were selected and included Celina, Melissa, Farmersville, the Outer Loop at NETEX and the Collin County Airport in McKinney. The study included a site selection matrix. The Farmersville site located at the intersection of the proposed Regional Outer Loop and the Kansas City Southern rail line was shown to have the best qualifications for the logistics hub and was determined to be the best choice. The study will be finalized at the end of 2010 and the publication of the study will be in January 2011. Discussion with Court members followed. Commissioner Hoagland gave comments to the Court saying there will be a need for this facility in the future and Collin County should have this under consideration; if Collin County doesn't do it, Hunt County will. (Time: 10:03 a.m.)

6. <u>AI-32833</u> 2011 Texas County & District Retirement System (TCDRS) plan provisions, Human Resources.

Cynthia Jacobson, Human Resources, presented the Court with options for plan year 2011 TCDRS (Texas County and District Retirement System) retiree increases. The options included a flat rate which gives an increase to all retirees, a CPI (Consumer Price Index) increase which gives increases only to those who retired within the last several years, or no increases for any retirees.

Individuals above the current CPI would not receive an increase. The CPI increase is three percent; the average retiree receives approximately \$22,000 per year. Insurance rates for the retirees were discussed by the Court. If an employee retires prior to the age 65, they will pay the full insurance rate.

Judge Self gave information on social security which has not given a cost of living raise for the past two years. Additional comments included an article written by Tim Pawlenty Governor of Minnesota who suggests bringing compensation for public employees more in line with the private sector and ending defined benefit plans for governments, which is what the county is already doing. Discussion with Court members regarding retiree increases followed. A motion was made to approve the 100% base CPI COLA (Cost of Living Allowance).

Commissioner Shaheen asked about a flat increase and commented that there are two CPIs, the CPI-U (Consumer Price Index for Urban consumers) and the CPI-W (Consumer Price Index for Wage Earners and Clerical Workers. He suggested a flat increase based on the CPI-W which appears to be a more accurate percentage. Ms. Jacobson explained that a flat increase would give an increase to every retiree across the board; a CPI percentage will give the increase to only those who have not received the higher increases in past years. Ms. Jacobson informed the Court that a decision must be made or last year's plan would be used for plan year 2011. Discussion with the Court followed.

Judge Self recessed the Court at 10:22 a.m. to allow Ms. Jacobson to obtain information on the CPI-W as requested by Commissioner Shaheen.

Judge Self reconvened the meeting at 10:31 a.m. and the Court continued with the discussion. Ms. Jacobson informed the Court the CPI-W is a negative point four. Commissioner Shaheen did not want to approve a negative.

Judge Self reminded the Court that there is a key difference between social security and TCDRS. Social Security has a federally mandated formula; a COLA is not in the TCDRS system. Additional discussion followed. (Time: 10:35 a.m.)
