ITEM NO. 1 President Self called to order the meeting of the **Collin County Toll Road Authority Board of Directors** at 9:50 a.m.

ITEM NO. 2 Consent agenda to approve:

President Self asked if any member of the Board or any member of the audience had an item they wanted pulled from the consent agenda for individual consideration. Director Hoagland wanted to discuss item 2a. Director Shaheen made a motion to approve the remainder of the consent agenda.

a. **AI-31532** Budget amendment in the amount of \$5,463,570 to establish the budget for segment 3 of the Outer Loop, Budget.

Director Hoagland wanted it noted he felt the County should be earning interest on this loan. Bill Bilyeu, Administrative Services, approached, saying this is not a loan; it's a transfer from the general fund. Director Hoagland again stated he felt the County Toll Road Authority (CTA) should be paying interest for the use of those funds and he proposed an interest rate equal to the amount the CTA would have to pay for bonds or something of that nature. Discussion followed. Director Jaynes wanted to give this suggestion more thought. He recommended approving this item but wanted to discuss Director Hoagland's idea in a future court.

Judge Self stated Director Hoagland's point was well taken but this would be a discussion for Commissioners Court. Mr. Bilyeu said there are time constraints and monies due for right-of-ways as a result of court orders. Director Hoagland agreed with approving this item today but he wanted to go back retroactively and get paid. Commissioner Jaynes made a motion to approve. (Time: 9:55 a.m.)




