GENERAL DISCUSSION

3. <u>Al-31640</u> Set Public Hearing dates for the Dallas North Tollway (DNT) 4b alignment for June 21, 2010 at 6:00 P.M. at the Celina ISD Middle School located at 710 E. Pecan, Celina, Texas, and June 28, 2010 at 1:00 P.M. Commissioners Courtroom on the 4th floor of the Jack Hatchell Administration Building located at 2300 Bloomdale Road, McKinney, Texas, Commissioners Court.

President Self, opened discussion on this item saying the North Texas Toll Authority (NTTA) held two meetings on the alignment of 4b; one in Denton County and one in Collin County. There was a total attendance of more than 700 people; however, there were no comments from the public. In a previous meeting, the County voted to hold two public hearings to allow citizens to give their comments on the alignment consideration. The public hearing dates were selected by Bill Bilyeu, County Administrator. Director Shaheen asked about the landowners. Mr. Bilyeu replied that there was not a list of landowners; however, the County could communicate with them by posting the meetings and using Facebook, Twitter and the County webpage. Director Jaynes stated he would vote against the item. He believes in public hearings but, the NTTA has a process going, they are going by the federal guidelines, and they will pick the alignment and then come back with more public hearings. By the County holding parallel public hearings it will be confusing to the voters. It has a potential to have a detrimental effect on the NTTA's environmental assessment and could run the risk of damaging their (NTTA) bond rating. There is also the possibility to further alienate future regional partners. Director Jaynes is in favor of the NTTA's process and would be more in favor of the County holding public hearings if it were after the NTTA process was completed. Director Jaynes wanted it to be known that he respects the process and if the Board votes on this, they would hear the public and respect what they have to say.
