3. **AI-32498** Environmental Assessment for Collin County Outer Loop, Segment 1 from US 75 to SH 121 (Project GT112A), Engineering.



There being no further business of the Board of Directors and no reason to recess into Executive Session, President Self adjourned the meeting at 9:36 a.m.






