1. President Self called to order the meeting of the Collin County Health Care Foundation at 9:32 a.m.

GENERAL DISCUSSION

3. **AI-32249** Reallocation of Health Care grant funds, Health Care.

Bill Bilyeu, Administrative Services, came forward. He stated that the Collin County Committee on Aging received a grant to help provide meals for the Meals on Wheels program which they operate. Mr. Bilyeu asked Julie Smith, Meals on Wheels, to come forward and present to the Court what the money will go towards. Mrs. Smith approached and began by stating that Meals on Wheels was awarded the Collin County Healthcare Foundation Grant, CCHCF, in January in the amount of \$18,720. This grant was specifically for senior citizens who are living at the 100% poverty level and are U.S. citizens. So far they have provided 958 meals and still have a remaining balance of \$12,972 as of Friday, July 23, 2010. Mrs. Smith went on to state that the program has been granted the Texas Feeding Texans grant in the amount of \$112,483.86 provided by the Texas Department of Agriculture Program but it has a stipulation. The stipulation is that the grant requires Collin County to pay \$0.25 per senior citizen based on the 2000 census which comes out to \$9,728.50. Mrs. Smith stated Meals on Wheels is requesting the Commissioners authorize a reallocation of the monies needed from the CCHCF Grant to cover the match the Texas Feeding Texans grant requires. The new

grant would be able to provide approximately 18,742 meals to Collin County seniors. Trustee Shaheen stated that he thought this had already been rejected by the Health Care Advisory Committee. Mr. Bilyeu stated that it had been presented before but Mrs. Smith was not there at the time. The Committee was not against the idea; they just had citizenship questions which the presenter could not answer at that time. She went on to say that the previous questions were regarding citizenship and that the grant would be put into the general fund and would only be used on senior citizens who are U.S. citizens. President Self asked if the criteria was the same. Mrs. Smith stated that it is not due to the fact that the Texas Feeding Texans grant will not require the senior to be at 100% poverty level but they do have to be a U.S. citizen. President Self then asked if they could grow the program by using the funds for seniors at a 100% poverty level. Mrs. Smith said no. She stated that the federal poverty rate for one person is \$902.50 per month and \$1,214 for two people. The program only has 38 seniors at this time that meet that federal standard and due to the regulation they have to deny seniors who are only making a slight amount more than the standard a month. Trustee Shaheen made a motion to approve. (Time: 9:42 a.m.)

4. AI-32237 Personnel Changes, Human Resources.

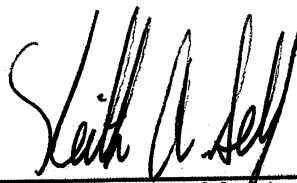

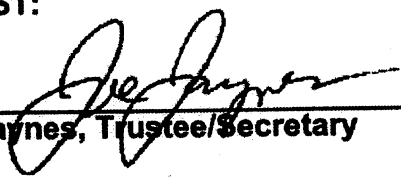
EXECUTIVE SESSION
