3. AI-32346 Personnel Changes, Human Resources.

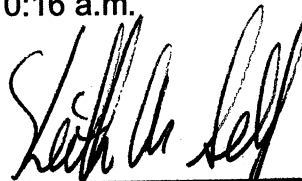
