1. Judge Self called to order the meeting of the Collin County Commissioners' Court at 1:31 p.m. and recessed into the Collin County Health Care Foundation.

President Self called to order the meeting of the Collin County Health Care Foundation at 2:04 p.m. and recessed the meeting into the Collin County Commissioners' Court.

Judge Self recessed the meeting of the Collin County Commissioners' Court at 2:05 p.m. and reconvened the meeting of the Collin County Health Care Foundation.

President Self adjourned the meeting of the Collin County Health Care Foundation at 2:07 p.m. and reconvened the Collin County Commissioners' Court.

GENERAL DISCUSSION

5. AI-33656 Medical Reserve Corps (MRC) and the Strategic National Stockpile (SNS) presentation, Homeland Security.

Eileen Prentice and Maria Stephens, Homeland Security, came forward to discuss the Strategic National Stockpile (SNS) and Medical Reserve Corps (MRC). Ms. Prentice stated the SNS is overseen by the Center for Disease Control (CDC) and consists of antibiotics, vaccines, antidotes, antitoxins, medical supplies and medical equipment to deploy in response to public health emergencies. She said the SNS is composed of two parts, the 12 hour push pack and managed inventory.

The 12 hour push pack is less than 5% of the total SNS inventory and is the first line of support. It is configured to be immediately loaded onto either trucks or commercial cargo airplanes to be delivered within 12 hours. The vendor managed inventory can be tailored to a specific threat and arrive within 24 to 36 hours.

Ms. Prentice discussed the SNS process. After a public health emergency the Judge can request assistance from the Governor, the Governor requests help from the CDC and they release SNS assets within 12 hours to a regional receiving, staging and storage site. They then deliver the assets directly to Points of Dispensing, PODS, throughout Collin County where MRC volunteers dispense them to the public.

SNS dispensing consists of two methods, push and pull sites. Pull sites are considered PODS which require community effort to operate and are placed close to where people live. Push sites are jails, juvenile detention facilities, nursing homes and the home bound population where the MRC would have to go to them.

Ms. Prentice stated PODS are large scale clinics planned to rapidly administer medications or vaccinations to all residents. They are designed to respond to a number of possible events and scenarios and are activated when normal public health systems must be supplemented.

Maria Stephens, Homeland Security, discussed the MRC and said it is a community-based, organized group of non-medical and medical volunteers. They are responsible for staffing PODS. She stated in 2008 they only had 487 volunteers and now they have 1,384.

Ms. Stephens said in the event of a wide-spread disaster, they estimate they would need approximately 5,400 volunteers to run 27 PODS countywide. She discussed the roles of the medical and non-medical volunteers. The volunteers can assist with communications and setting up mobile medical units along with many other duties.

Ms. Stephens stated the MRC volunteers currently are partnered with Meals on Wheels and offer amateur radio support for the Collin Classic Bike Rally along with supporting other city events. From January 2009 until the present day the MRC volunteers have completed 9,267 community service hours which is equivalent to \$219,094.36.

Judge Self asked how many of the volunteers are first responders. Ms. Stephens stated she has approximately 300 nurses, 40 EMT's, along with doctors, nurse practitioners and other emergency personnel. She said she focuses on recruiting school nurses because they will not be in school during a disaster and can help. Judge Self asked how the MRC would handle a disaster which consists of a disease or bioterrorism situation and dispersing the assets so the public would not have to meet at a POD and expose themselves. Ms. Prentice said the program needs to mature and the next step is to grow the program to work out the issues such as implementing drive through PODS and working with Homeowners Associations for disbursements. Commissioner Shaheen stated he was very impressed and asked about the drills they have performed on PODS. Ms. Prentice said they have drilled approximately one fourth of their total 27 PODS in the county. He also asked if they have a list of the push sites such as nursing homes. Ms. Prentice stated they have a list of all of them as well as bed counts and they meet with them periodically to keep an updated list and a form of action. Commissioner Shaheen asked about the radio clubs and Ms. Stephens stated she is a member of the McKinney Amateur Radio Club and they are in contact with other radio clubs for communications.

Commissioner Webb asked how they recruit new volunteers. Ms. Stephens said it's about getting the word out in the community and they are growing mostly by word of mouth. (Time: 1:59 p.m.)

Judge Self placed this on the agenda because they have been appointing people on important Council of Governments (COG) committees. He made a motion to include the position and the board on the agenda for major committee appointments such as countywide, state-wide and COG boards. Commissioner Jaynes second the motion but

asked if they could include all board and committee appointments. The Judge amended his motion. (Time: 2:03 p.m.)
