GENERAL DISCUSSION

Presentation, discussion and any action regarding:

5. AI-33738 Compensation analysis and benefits, Human Resources.

Cynthia Jacobson, Human Resources, presented an overview of the Texas County and District Retirement System (TCDRS). She stated the employee deposit rate is 7% and the County matches at 200%. The vesting period is eight years and this number cannot be changed. She discussed a comparison between other counties and showed counties which allow 20 years of service for retirement at any age while all others require 30 such as Collin County. In the city comparison, most cities are at a 200% match.

She stated over a 30 year period the TCDRS has maintained a 10.3% rate of return. If the TCDRS does not maintain an 8% rate of return then the additional expense will be paid by the county as an additional liability.

Ms. Jacobson presented the rates as a percentage of payroll. At this time, the county is paying approximately 2.9% of an \$86 million payroll due to unfunded liabilities. She said the County has always paid a Cost of Living Adjustment (COLA) and this increases the rate. The County has always paid more than the expense to decrease the amount of unfunded liability. In October 2009 the County made a \$1.13 million lump sum payment and another \$5 million in October 2010.

The unfunded liability as of December 2010 is \$34,553,335. TCDRS did have positive returns in 2011 but they practice the smoothing process and the gains will be recognized over a 10 year period.

Ms. Jacobson discussed the unfunded liability history and presented how the rates dropped from 2009 to 2010 causing the unfunded liability to increase. She said as of December 31, 2009 the unfunded liability was \$40,273,715. The Court lowered the match and decreased the unfunded liability by \$3,964,446. Interest earned on the unfunded liability at a rate of 7% was \$3,267,834. The lump sum payments and the

regular contribution payments totaled \$8,916,249. The recognized loss from the decrease in the rate of return was \$2,340,750. Other payments totaling \$1,551,731 were due to TCDRS anticipating the payroll growth at a higher rate than what actually happened. The total unfunded liability as of December 31, 2010 is \$34,553,335. Commissioner Jaynes asked how long the unfunded liability goes out and she said it is 20 years maximum if the County did nothing. TCDRS determines the rate by numerous actuarial assumptions and when it is off they adjust either up or down.

Commissioner Webb asked if the County was ever fully funding the TCDRS. Ms. Jacobson said over the years there have been numerous benefit changes that were elected for the entire time frame rather than for that time moving forward and they had to pay for it. The County has also done COLA's and that amount is funded over a 15 year period. Ms. Jacobson discussed the COLA options and how the court determines the cost of living increase each year. Last year, a 100% Consumer Price Index (CPI) increase was approved. For the 2012 plan, if they choose a 100% CPI increase the estimated annual cost will be \$60,200.

Ms. Jacobson said if they continue the contribution rate of 13.5% then it will result in an estimated additional payment of \$2.6 million toward the unfunded liability. If they continue the 13.5% payment plus pay \$5 million additional for the next three years, the unfunded liability is projected to be paid in full by approximately 2019 if TCDRS assumes a rate of 8%.

Commissioner Webb asked Jeff May, County Auditor, what the rate is on the rainy day fund. Mr. May stated they are averaging 1% and invest short-term. Commissioner Webb said he would like to look into using the rainy day funds to pay down the unfunded liability. Mr. May said the current fund balance is approximately \$129 million. Mr. May stated this particular liability is not on the balance sheet. Commissioner Williams said she would like to see how making a lump payment would affect the bond rating. Mr. May said they have looked into that previously and it should not affect the bond rating unless the fund balance goes below a certain number.

Commissioner Shaheen made a motion to give direction to the Budget Department to perform the scenario involving a 13.5% payment plus an additional \$5 million payment. Commissioner Jaynes second the motion but Commissioner Williams asked that they see two scenarios.

Commissioner Shaheen amended his motion to give direction to the Budget Department to perform two separate scenarios: the first being to assume a 13.5% payment plus pay \$5 million lump payment toward unfunded liability and the second being to pay off the balance of the unfunded liability in full. (Time: 2:05 p.m.)
