Commissioner Webb asked Jeff May, County Auditor, why there is a substantial increase for liability in accounts payable on page 283. Mr. May said this fluctuates from time to time and the increase was due to a payment to the city of Frisco for construction of a road. Commissioner Webb asked why they went from a negative value to over \$16.5 million in deferred revenue. Mr. May stated this was due to Regional Toll Revenues (RTR) funds being received. The funds cannot be reported as revenue until they are spent and then listed as deferred revenue. Commissioner Webb asked why there are negative fund balances under the Capital Project Funds on page 338. Mr. May said these are projected fund balances and each one is different. He said Fund 408 was due to the water pipe project at the Sheriff's office and this fund is to be adjusted. Fund 412 is due to a bond issue that was split between two funds after they started spending the money. At some point they will make an adjustment to move the expenditures from one fund to the other to clean it up. Commissioner Webb asked if they transfer funds from the general fund when there are negative balances in the federal grant funds. Mr. May said they spend the money before they receive it, therefore, it shows as a negative. Commissioner Webb asked if a transfer from the general fund to the juvenile probation fund was a quarterly or annual payment. Mr. May said this is budgeted transfer done every year. Commissioner Webb made a motion to approve. (Time: 3:49 p.m.)

GENERAL DISCUSSION

- **5.** <u>AI-33973</u> Texas AgriLife Extension Projects at Myer Park & Event Center update, Special Projects.
- Dr. Steve George, Texas AgriLife Extension, discussed the Earth-Kind program. He stated Myers Park is the premier location in the nation for people to see how the Earth-Kind program works. The program shows important techniques on how to manage the landscape during drought conditions and other scenarios. He listed well known horticulturists and other professionals who will be coming to Myers Park from all over the nation to see the Earth-Kind program.

Dr. Greg Church, Texas AgriLife Extension, discussed the projects and the Earth-Kind goals to conserve water, reduce fertilizer and pesticide use, produce energy and reduce waste in landfills. He presented photos of the Earth-Kind gardens and how they tested the drought tolerance of different plants. He discussed the rain harvesting project and the drip irrigation system.

Dr. Rick Maxwell, Texas AgriLife Extension, finished the presentation with pictures and discussion about pasture grasses. He stated they are using the Earth-Kind approach to research what pasture grasses will thrive in this area. (Time: 1:46 p.m.)

6. <u>AI-33738</u> Compensation analysis and benefits, Human Resources.

Cynthia Jacobson, Human Resources, presented the Ancillary Benefits which consist of all benefits other than medical and retirement. She discussed voluntary employee paid benefits which are optional.

The other benefits discussed were the county paid ancillary benefits. The largest county paid benefit is paid leave. Paid time off (PTO) is a combination of sick time, personal time and vacation time in one lump sum. The accrual of hours is based upon years of service with the County. Catastrophic time off (CTO) is accrued once per year in the amount of 24 hours to a maximum of 160 hours. Catastrophic carryover is the unused sick time employees had when the County revised the leave plans in 2006. Therefore, employees hired after January 1, 2006 do not have catastrophic carryover. Commissioner Webb asked how many accrued days would an employee who has one year of service have. Ms. Jacobson said they would have a total of 27 days; three for CTO and 24 for PTO. She presented a comparison between other counties and cities. Collin County is comparable with other similar entities.

An employee is required to work one year before they are allowed a payout of their PTO time if they choose to leave the County. Currently there are 250,409 hours liability in PTO time. This averages to be 160 hours per employee. Previously there was a \$7 million liability regarding catastrophic carryover. After the revision in 2006 this decreased the liability which currently is \$3,866,430. Ms. Jacobson said in 2010 they paid out 13,689 hours of PTO for a total of \$311,125.

Collin County offers compensatory time off to exempt and non-exempt employees who work in excess of 40 hours in a work week. This is not found in the private sector and is only allowed in the public sector. There are two types of compensatory time: straight and premium. Straight compensatory time is for exempt employees and is calculated as one hour for each hour worked in excess of 40 hours. This time is not paid out if the employee leaves. Non-exempt employees receive premium compensatory time which is calculated as one-and-a-half hours for each hour worked in excess of 40 hours. This time is paid out if the employee leaves. Changes were made in this program in 2010 where exempt employees cannot accrue more than 80 hours compensatory time. Collin County is comparable to other entities who offer the same time program.

Regular full-time employees are eligible for ten paid holidays a year. In 2010, Collin County paid \$2,888,618 in holiday pay. Other local entities offer eight to twelve paid holidays per year.

Collin County offers longevity pay to full-time employees who were approved by Commissioners' Court on or prior to the December 18, 2007 agenda. The County paid \$3.7 million in the past year for longevity which is more than what was paid before the program was removed. District Attorney Prosecutors receive state mandated longevity pay paid by the state. The County reduces their longevity pay by the amount paid by the state. Deputy Sheriffs also receive state mandated longevity pay. If the deputy was employed before the December 18, 2007 agenda they are grandfathered into county longevity rather than the lower law enforcement longevity.

Ms. Jacobson discussed shift differentials. Shift differentials are the premiums paid to employees who work the second and third shifts for the Sheriff's Office, Juvenile Detention and Facilities. Not all local entities offer this benefit.

Car allowances are given to the Sheriff, Chief Deputy Sheriff, District Attorney Investigators, Road and Bridge Superintendent and Assistant Director, County Extension Agents, Youth Park-Parks Manager and Events Coordinator, Building Projects Coordinator and Veteran's Service Officer. The amount of car allowance varies per position. She said in 2010 the county paid \$173,850 in car allowances.

Collin County pays the full cost of short term and long term disability benefits for full-time employees once they reach 90 days of employment. Short-term disability is self-funded and the County pays an administration fee while long-term disability is fully insured and the County pays a premium. It is unusual for a County to pay for short term disability but most other entities offer unlimited sick time in place of this benefit.

Ms. Jacobson stated the County provides employees with \$50,000 in basic life insurance and \$50,000 in Accidental Death and Dismemberment (AD&D) insurance. In 2010, Collin County paid \$86,733 in basic life premiums. The majority of local entities offer the same amount.

Collin County provides basic long term care insurance coverage at no cost to regular full time employees with at least eight years of eligible service. Collin County is the only local entity where this benefit is paid by the employer.

Ms. Jacobson discussed tuition reimbursement and said most other entities offer this benefit.

Ms. Jacobson discussed Workers' Compensation and said the County pays employees who are injured on the job 100% of their salary for up to 12 weeks which is higher than the 70% required by the State.

Jeff May, County Auditor, stated the liability reported on the coffer is only for non-exempt compensatory time and PTO which is \$6.6 million. The other liabilities are not reported because they do not pay cash when the employee leaves.

Commissioner Webb asked when it was instituted that an employee could earn three days a year of CTO. Ms. Jacobson said this was implemented when they switched over to PTO. This was not put into place to cover the waiting period for short-term disability. She said the conditions for taking CTO time are very broad. Commissioner Webb said he would like to see when the Catastrophic Carryover will diminish. (Time: 2:07 p.m.)

7. <u>Al-33982</u> Continued participation in the countywide polling place program (Vote Centers) for the November 8, 2011, Constitutional Amendment Election, Elections.

Sharon Rowe, Elections Administrator, said she has been working with the State Elections Director on the timing and how the State is still discussing what constitutes a successful program. She is preparing an agenda item for August 22nd which will include a public hearing to hear public input and propose early voting dates. Commissioner Shaheen asked about the previous issues concerning bottlenecks and number of computers. Ms. Rowe said they are in the process of purchasing equipment. Commissioner Williams asked if they could look into the issue of parking and different locations where people will gravitate to. Commissioner Jaynes asked Ms. Rowe to see if election judges would participate at the public hearing. (Time: 2:13 p.m.)

8. <u>AI-33983</u> Options for contract election services available to Cities, School Districts, and Special Districts for the May 2012 Uniform Election Date, Election.

Sharon Rowe, Elections Director, said Senate Bill 100 changes the dynamics of contract election services. She proposed four options for the city, school and special district elections. Option one is to get to an odd-numbered year cycle with two to four year terms. Option two is to join the County on the November uniform election date. In her budget she would propose to look at a way to entice jurisdictions who need help with financing during November elections. Option three is for them to stay in May elections of even-numbered years and she, as the Elections Administrator, coordinates a contract with Dominion, the vendor who supports the County presently. Option four is for them to stay in May elections of even-numbered years and manage elections individually and with a vendor of their choice.

Ms. Rowe discussed option three in detail. She stated there are duties she is asking the districts to see if they can perform themselves. She can coordinate a contract but she doesn't feel she can perform all the election clerk duties. There is a potential for errors and the process is very time consuming. She said she would need another member of the staff to assist with early voting and another person to perform project management on overlapping election cycles who can work with Information Technology.

Maher Maso, Frisco, said he feels in the past they have worked well as a team to make it easier for the citizens to cast their votes in elections. He said there is still an issue in the 2012 May election regarding early voting and mail ballots. They do not have the supply or staff to run their own elections where the County has very seasoned employees. He feels the County knows how to run the elections and have done a great job.

Dr. J.D. Kennedy, McKinney, voiced his appreciation for Sharon Rowe and her elections team. He feels it would be good to keep providing services as they have in the past. He would like them to consider a fifth option where services are provided in full as they have in the past.

Dr. Rick Reedy, Frisco, discussed the issues he has with Senate Bill 100. He feels the elections should be kept the way they are. He stated they employ the county to ensure they have the space and the resources available to make the elections run smoothly and properly. He discussed his issues with the proposed options from a prepared speech.

Commissioner Shaheen said it seems there is a desire to keep things the way they are. He asked Ms. Rowe how the logistics would work if there was a primary election in May. Ms. Rowe said they are working on the details. She said regardless of what option they choose, a vendor would still be needed to assist with certain duties. She also said they would not have enough machines. If the elections stay in May they would need an additional 700. She said if they chose to let the vendor handle the May elections they would cover the machines and coding. She has a proposal for the budget asking for additional staff to assist with a May election. Judge Self clarified that if they hold a Saturday and Monday election, the elections cannot be held in the same location and the jurisdictions will have to work directly with the vendor if they go with Ms. Rowe's option. Ms. Rowe and two of her staff members can assist with early voting and project management. Judge Self asked the cost of option three. The other cost for the County would be \$30,000: \$20,000 for a dedicated server and \$10,000 for a license fee. This does not include the additional staff. She said the vendor is estimating \$45,000 for coding, \$22,000 for project and accuracy testing and equipment services. If everyone stays in the election, the estimated equipment services cost would be approximately \$55,000. These costs would be incurred to the jurisdictions and not the County. Machine rental cost would be in addition to these costs. Commissioner Williams discussed her thoughts on the option choices and how she felt this would be a great opportunity for standardization of future elections. (Time: 2:51 p.m.)

9. Al-34004 Juvenile Detention facility capacity compared to staffing, County Judge.

Bill Bilyeu, County Administrator, discussed the comparison between staffing and the Juvenile Detention population. He stated that even though they house 100 beds this does not mean they can house 100 people due to them needing to be separated because of sex, risk and other factors. Joe Scott, Juvenile Probation Director, said the population of the Juvenile Detention Center has a trend of going down in the summer and increasing in August and early September. Judge Self asked if the Juvenile Board has addressed the fact they are staffed for 132. Mr. Scott said they have three vacancies in detention at this time and they will not fill these positions until the population increases to approximately over 100. (Time: 3:07 p.m.)

10. <u>AI-33987</u> Commissioners redistricting update, County Judge.

Bill Bilyeu, County Administrator, said the various maps presented are some he created and others are compilations of the things he has heard from the Commissioners. He suggested they do a workshop to make a decision on redistricting. Commissioner Webb discussed his thoughts on how he would like his precinct to be larger. Commissioner Williams said she feels the most logical place to lose population is from where they gained it a year ago. She discussed her thoughts on how Dallas shouldn't be divided between two Commissioners. The Court discussed their thoughts on moving districts and how they will all have to give and take. Mr. Bilyeu said if the new districting is effective January 1, 2013, then the people who run for office in 2012 will run for the new precincts. Judge Self asked Mr. Bilyeu to schedule a workshop to discuss redistricting. (Time: 3:18 p.m.)

11. Possible future agenda items by Commissioners Court without discussion.

Judge Self asked for possible future agenda items. Commissioner Webb would like to look into Catastrophic Time Off. (Time: 3:50 p.m.)
