GENERAL DISCUSSION

Presentation, discussion and any action regarding:

5. <u>AI-34369</u> Tax Abatement and 381 Agreements, Administrative Services.

James Shepherd, Shepherd Law Firm, gave a presentation regarding the Collin County Tax Abatement Program which showed the differences between Tax Code Chapter 312 and Local Government Code Chapter 381. Mr. Shepherd stated he feels Chapter 381 would be the easiest and least procedural option. Chapter 381 is usually referred to as a grant program but it can be compared as an abatement program. Under Chapter 381, the program can be specific to each applicant or it can be issued as a blanket program. Mr. Shepherd presented a list of requirements for Chapter 312 that Chapter 381 does not require. In Chapter 381 Mr. Shepherd recommended the agreement requirements includes providing for recapture in the event of default, the applicant's annual certification of compliance, to cancel or modify in the event of default and written agreements required with a municipality. The Court discussed the options for agreements with municipalities and the limitations on certain businesses. Mr. Shepherd stated Commissioner Webb made revisions on the Chapter 381 policy for review.

Commissioner Williams asked if administrative costs would be shared between the members. Bill Bilyeu, County Administrator, said yes. Under Chapter 312 there would be cost to the Central Appraisal District (CAD) that would not be present under Chapter 381. He said there would be more staffing costs involved if the Chapter 312 option was chosen rather than Chapter 381 due to cities' involvement. He stated they would try the first year without adding staff and would use the Commissioners' Court clerical staff for that time.

Mr. Bilyeu said there would be approximately 700 to 800 new vendors coming into the system per year and this would not be a burden on the Auditor's office.

Judge Self suggested adding the cities' input and excluding tax increment financing (TIF) and tax increment reinvestment zones (TIRZ).

There was discussion regarding creating a list of businesses that would be excluded from the tax abatement program.

Commissioner Shaheen said he would like a requirement of five full-time employee equivalents. There was Court discussion regarding how to track employees such as obtaining an employment report from the Texas Workforce. The Court discussed threshold options and amounts.

Mr. Bilyeu presented a timeline saying the Court should have feedback from the cities and everything in place before January 1, 2012. The new policy should become

effective January 1, 2012, with a deadline of December 10, 2011. If a business opens their doors before January 1, 2012, they are not eligible for the program. (Time: 2:41 p.m.)

Mr. Bilyeu discussed the major changes for the tax abatement policy. The biggest change would be the threshold. The second part is the addition of information from the cities showing the business meets the requirements for the abatement. Judge Self said the policy is too general. Commissioner Williams said this is a Chapter 312 program where the cities are in control that was created by the legislature where the counties are just tagging along. Mr. Shepherd said in speaking with the cities, they expect there to be discretion and something should be in place to say where and when a business goes into place.

There was Court discussion concerning a threshold amount and the benefits of the program for larger companies and smaller companies.

Language needs to be added to address a minimum amount with a caveat that they are able to go above that amount and monitor documentation. (Time: 3:10 p.m.)

Ruben Delgado, Engineering Services, said they met with TxDOT Engineering Director, John Barton regarding mandatory federal guidelines for bike paths. He said there would be one extra foot added to each side of the road. Mr. Delgado calculated there are approximately 45 miles of TxDOT roads these guidelines would affect. Any future Farm to Market roads or state highways will have a bike path incorporated as well as roads that undergo renovation. (Time: 3:18 p.m.)
