Commissioner Shaheen requested additional information regarding the source code being proprietary to the vendor. Bill Bilyeu, County Administrator, came forward with additional information. After the product had gone through several transitions the Department of Justice objected and required the product to be sold in different variations. Dominion ended up with the software support. The equipment is proprietary so no one else can touch it. Commissioner Shaheen asked about getting source code. Mr. Bilyeu replied they cannot get source code on a voting system; it is first approved by the federal government and then by each individual state.

Commissioner Shaheen had concerns that if the vendor were to go out of business, there would be no one to support the system. After additional brief comments, a motion was made to approve the item as submitted. (Time: 1:36 p.m.)

GENERAL DISCUSSION

5. AI-34401 North Central Texas Fusion Center presentation, Homeland Security.

Commissioner Shaheen prefaced the discussion by informing the Court he had asked Kelly Stone to give a presentation outlining the benefits of utilizing the fusion system.

Kelley Stone, Homeland Security, addressed the Court with a power point presentation that gave an informational overview of the North Central Texas Fusion System. The system has been operational since 2006 and currently supports 1100 regional users from 168 agencies. It consists of structured data, of which 90% is law enforcement, as well as open source data, evidence from crime scenes and witness interviews.

Examples of how the system has been used successfully included a complex multiple homicide investigation which allowed electronic access to information. The system was also used to assist the District Attorney and the Sheriff's Office. In addition, the system provided threat assessments on such venues as Pizza Hut Park, the Texas Motor Speedway and Cowboy Stadium.

The system was also used to assist the Collin County Children's Advocacy Center in locating a witness in a case of sexual assault of a child. They also located a fugitive sex offender who had been on the run for two years and enabled law enforcement to have the suspect in custody within 24 hours.

Mr. Stone next discussed the cost of the system and provided a chart of the build out and maintenance costs since 2006. The highest cost came in 2007; however, they were able to have a consultant write a program that reduced that cost in 2008 and it did not require any updates. The amount was reduced again in 2010 by \$36,000 by collaborating with the county's IT department for providing maintenance. Currently they pay \$10,000 to have the data indexed; however, due to the efforts of the county's IT department and utilizing COPLINK, that cost will be eliminated.

A chart of registered usage was also shown from 2006 through 2011. From May through July 2010 there have been 1,048 logins and 16,679 pages of information viewed. Mr. Stone explained that in order for a law enforcement official to view the information, they must have probable cause or a reasonable suspicion that a crime has occurred or may occur. An officer cannot perform random queries on individuals.

Judge Self asked what safeguards were in place to prevent random searches. Mr. Stone replied that a law enforcement user must have approval by their Chief, the Sheriff or a designee.

Commissioner Shaheen expressed his appreciation to Mr. Stone for providing the court with the benefits of using the fusion system. Commissioner Webb gave comments regarding the expenditures and that the local dollars being spent appear to be through the county's IT department and asked if they were supporting the system. Mr. Stone replied that they are in the process of transitioning to COPLINK which was approved last November by the Court. They are moving from a 20 year old process to a more automated system. IT will consolidate the data into a SQL database that will allow the system to stay in place with only minimal support from the taxpayer. (Time: 1:50 p.m.)

Commissioner Williams attended the meeting in place of Commissioner Webb who was unavailable. She began the update saying there were three main issues that came out of the meeting. First, there was some initial thought that the Census Bureau might expand urbanized areas which could have an impact on the City of McKinney. After looking at the subject, the city thought they could benefit from being part of a larger urbanized area. The RTC and The City of McKinney will ask the Bureau to expand the area, but it is unlikely that will happen. Secondly, there was discussion about the Outer Loop and the fact that portions of it have been pulled off of the 2035 Plan. The RTC does not expect to provide any additional support or funding for the blue segments which have been deemed unfeasible at this time.

Judge Self asked about any comments on the green lines which go across Denton County; they have been very vocal about not wanting that segment. Commissioner Williams replied that there was no one at the meeting that made any comment. Commissioner Webb added that Denton County had not made any comments on the Outer Loop since he has been on the Board.

The third item is regarding the air quality update. They were doing fairly well in continuing to get closer to the constraints of air quality; however, this past summer we have failed primarily due to weather issues. (Time: 1:54 p.m.)
