2. <u>AI-34423</u> Application for a Slaughter Facility submitted by Ayachi Investments, LLC to be located at FM 1377 and CR 494, Development Services.

Misty Brown, Development Services, stated on September 1<sup>st</sup>, 2011, state law changed to allow Collin County to be covered under Local Government Code 234.033 which means the Commissioners' Court can approve the location of slaughter plants. The Commissioners' Court can prohibit the operations of a slaughterer if:

- (1) They are within 1,000 feet of a school or residence; or,
- (2) At any other location if the Commissioners' Court finds that the operation of a slaughterer's business is incompatible with the existing land use of the neighboring area or would impose an undue hardship on persons residing or trading in the neighboring area.

Continuing, Ms. Brown said on September 13<sup>th</sup>, 2011, they received an application for a new slaughter plant. A study showed there are five residential properties located within 1,000 feet so the application was being brought before the Court.

Mostapha Ayachi stated he purchased land in Princeton about a year ago. He owns several Subway and Church's Chicken franchises. Mr. Ayachi is from North Africa and he said there is a great demand for Kosher and Halal meat. Raw meat would not be sold from this facility. Mr. Ayachi said based on religion and holidays, the Muslim people purchase live animals, slaughter and process them. He stated he would engage the services of a company that would follow the proper procedures for the disposal of blood and innards. Commissioner Jaynes said he would vote against this item. He felt the legislation should work in this case and he made a motion to deny the request. (Time: 2:35 p.m.)
