Dear Judge Payton,

Per your email of October 21, 2011, please find the signed and (revised) addendum and extension letter attached.

The addendum to our Cooperation Agreement is merely to acknowledge our Agreement with Discovery Studios. Mr. O'Leary is correct that our intent was not to have the County waive some of the obligations of Producer established in Paragraph 10 (b). We believe the revision to the addendum letter addresses Mr. O'Leary's concerns. The second letter extends the Term of our Cooperation Agreement to the same Term as our Agreement with Discovery Studios, which is August 30, 2011 – August 30, 2012.

Bill,

I have reviewed the original Agreement with TVpug Entertainment and the proposed addendum that is attached to this email. As we discussed by phone, the original Agreement does give Collin County some rights to review the proposed content and make suggestions to the Producer. Even though the Producer retained final control over the product, Paragraph 10(b) does require the Producer to communicate with Collin County in the development phase.

Paragraph "2" of the addendum may alter these obligations. As written the addendum is broad and does not really identify a specific paragraph or issue being amended. It may not be the intent of the Producer, but the effect of the addendum may waive some of the obligations of Producer established in Paragraph 10 (b). I would prefer that Paragraph 2 of the addendum actually identify what specific paragraph and terms it is amending. Also, I would recommend that the addendum specifically refer to paragraph 10 (b) of the original Agreement as unaffected by the addendum.

Please let me know if you need anything further on this issue.
