

## NorthSTAR Service Information by Participating County

The Information in this workbook covers FY06-FY10, and is derived from NorthSTAR service and medication encounters and state hospital utilization data from the NorthSTAR data warehouse. It also incorporates excerpts from ValueOptions financial reporting to DSHS, which is via a separate report. Also used is 2010 US Census data to depict federal poverty information. The multiple worksheets in this workbook show trends from various perspectives. The worksheets that depict detail level service data are for 2010 only. **With the exception of medication encounter data tables (VO specific data for non Medicaid enrollees), and data on worksheet 15 (non Medicaid persons with LOCA), all data includes Medicaid and non Medicaid NorthSTAR enrollees.** Due to the volume of data in the DSHS data system, data from FY 2000 - 2006 has been archived. While these data may be made available, it is not readily accessible.

**FY10 data is mostly complete.** The table of contents below has links to bring the reader to various worksheets. Once at a worksheet, use the scroll bar at right to move thru the document. Click the link in the top left hand corner of the worksheet to go back to the table of contents.

The NorthSTAR Program is a publicly funded managed care approach to the delivery of mental health and chemical dependency services to the eligible residents of Dallas, Ellis, Collin, Hunt, Navarro, Rockwall and Kaufman counties. Eligible individuals include most Medicaid recipients who reside in the service area and in the community, and individuals less than or equal to 200% of the federal poverty level (FPL), who meet clinical need. NorthSTAR combines multiple state, federal and local funding streams into one program. NorthSTAR provides a comprehensive mental health/substance abuse benefit package for all eligible individuals, and access to benefits is determined by assessed clinical need, not funding source. **NorthSTAR is a partnership.** As a partnership, it is crucial that all stakeholders receive unvarnished information about the status of the program, that the program operates in a transparent manner, and that it is responsive to stakeholder concerns.

The data in these worksheets represents high level utilization trends and expenditure trends for each county in the NorthSTAR program. While data can be interpreted in different ways by different people, there are some notable observations that can be taken away from review of these data:

- Not all counties have the same demographics. Per capita income varies, as does educational status and employment
- Utilization of services by residents of counties (which translates into dollars expended) lines up relatively well with the demographics of participating counties. Some counties' utilization trends are higher than their demographics would suggest, and some are lower. Dallas, Hunt and Kaufman generally experience higher utilization than their demographics suggest, and to varying degrees, Collin, Ellis, Navarro and Rockwall experience less.
- Why the disparity?
  - Service Delivery frequency and intensity by providers varies.
  - Types of services delivered by providers vary.
  - Access to services is generally greater in urban areas than in rural areas.
  - It is difficult to encourage providers to expand into rural areas.
  - Providers generally do not deliver all the services they are authorized to provide. This also varies widely by provider.
  - Marketing and general knowledge of program may vary county to county.
- According to the data, there is not a clear correlation between amount of services provided in a county and acute care usage.
- Although NorthSTAR is not the lowest general revenue funded area on a per capita basis, NorthSTAR ranked below the mean. A further analysis shows that NorthSTAR is clearly serving many more non Medicaid persons than other LMHAs with its general revenue funds, resulting in the lowest expenditure of general revenue funds per non Medicaid person served.

### **Some Possible Next Steps:**

- It is completely reasonable for each participating county to want the most out of the program for its citizenry. County involvement, feedback and/or critique is necessary to keep the program evolving and responsive.
- Continued dialogue and information sharing among DSHS, NTBHA, ValueOptions and stakeholders is a vital part of this program.
- Strengthening NTBHA is crucial. Developing NTBHA staff expertise is critical. All important aspects of the program (program or system changes, provider rates or reimbursement structures, provider network changes, etc) require both DSHS and NTBHA review and approval.
- Continued work with NTBHA on developing their data analysis expertise and contract oversight expertise.
- Continued marketing of the program to all counties
- Continue analysis by NTBHA of the provider network adequacy.
