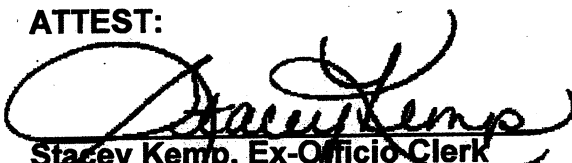

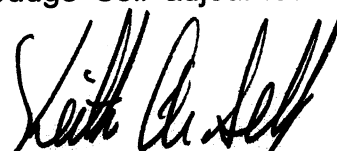

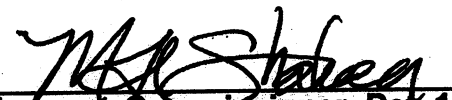
There being no further business of the Court, Judge Self adjourned the meeting at 9:32 a.m.

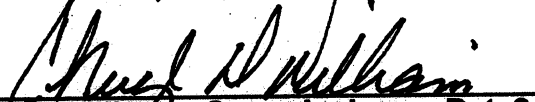


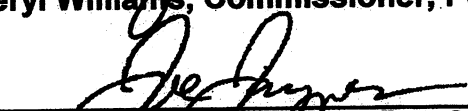
