1. President Self called to order the meeting of the <u>Collin County Health Care</u> <u>Foundation Board of Trustees</u> at 6:03 p.m. The meeting was recessed at 6:13 p.m. and reconvened at 8:00 p.m.

- 1. <u>AI-33162</u> Budget amendment in the amount of \$19,320 to transfer funds between project codes for the Cities Readiness Initiative Grant, Auditor.
- 2. Consent agenda to approve. President Self asked if any member of the Board or any member of the audience had an item they wanted pulled from the consent agenda for individual consideration. Trustee Webb pulled all of item 2b and item d1 for consideration. President Self stated item d3 would be deleted from the agenda. Trustee Webb stated the reason he pulled the items in 2b is because all of the orders have the former commissioners' names rather than the current commissioners' names, so he would like to have those modified.

Trustee Webb had a question related to attorneys' fees in the contracts. He believes the prevailing party should be entitled to recover their attorneys' fees. Bill Bilyeu, Administrative Services, said if the Board approves with that change, they will have the wording redone and resubmitted. Trustee Webb made a motion to approve with respect to Allen Community Outreach. President Self said let's change all six contracts with that language.
