1. President Self called to order the meeting of the Collin County Health Care Foundation at 2:46 p.m.

GENERAL DISCUSSION

3. AI-34508 Project Access Collin County Bi-Annual presentation, Health Care.

Candy Blair, Health Care Services, came forward to introduce John Ernst and Joshua James, M.D., of Project Access-Collin County (PACC).

Dr. James, Medical Director and Volunteer Physician of PACC, thanked the Board for their support and informed them that this project gives patients an opportunity to receive treatment that they may otherwise not receive.

Mr. Ernst came forward to give the Board information on the project which included statistics through November 7, 2011. The presentation included the number of physicians that have been recruited versus the goal which was 100 physicians in 12 months; in six months 71 have volunteered with 23 primary care physicians and 48 specialists. The goal for hospitals was to sign up eight within 12 months; seven signed up within two months and the eighth signed recently.

Mr. Ernst next discussed patient totals. The county referred 71, physicians referred 13 and hospitals referred two; there were 10 that were referred but did not meet guidelines. A map depicting physician offices, hospitals and patients' residences followed. Statistics also included patient values and amount of pharmacy assistance secured.

All patients have been given a primary care physician. Prescriptions, diagnostic testing and lab work was either paid for by PACC or the services were donated. The hospitals have accepted all patients referred to them for hospital care or diagnostics.

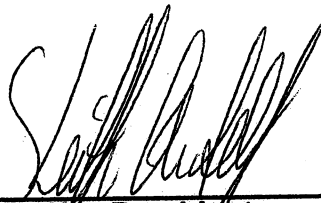
The number of indigent patients using hospitals has decreased to less than 10% mainly because they can receive needed care without going to a hospital. Trustee Webb asked how many the county had prior to the implementation of the program. Ms. Blair came forward in response. It is difficult to get an exact number because the majority of the previously received referrals had already been in hospitals; the average was approximately 15 at minimum. The budget for previous in-patient care was \$1.2 million. Mr. Ernst informed the Board that in the PACC program there is no cap on the amount of care provided. Services are donated by physicians and other volunteer providers. There are currently 27 Primary Care Physicians in the program and 684 slots available for indigent patient care. The program is on track to surpass their one year goal by April 2012 which is two months early, and there are resources to support an increase in patients over the next six months.

Trustee Webb asked about receiving physician support around the county and how they are distributed. Mr. Ernst replied that there is a fairly good distribution; however, the majority of the providers are in McKinney, Plano and Frisco. A brief discussion with the Board followed. Trustee Shaheen expressed his gratitude to the medical community for their support. (Time: 3:03 p.m.)

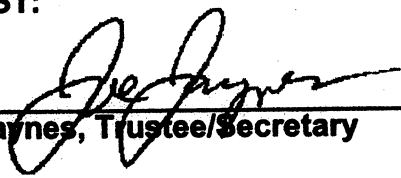
EXECUTIVE SESSION
