Commissioner Shaheen asked who entered into the agreement. Mr. May

said he can find out more about this before the disbursement is made. Commissioner Webb wanted more information.

Jon Kleinheksel, Public Works, came forward to request a public hearing for the placement of regulatory signs on various county roads. Judge Self opened the public hearing at 2:45 p.m. Hearing no comments, Judge Self closed the public hearing. Commissioner Jaynes made a motion to approve. (Time: 2:45 p.m.)

Jeff May, County Auditor, came forward with the Regional Toll Revenue report. This report represents money the State is holding, not County funds. Mr. May focused on the fourth quarter reports. As of September 30, 2011, there was \$793 million available for projects in Collin County. There were investment revenues of \$1.4 million. That number drops every quarter because interest rates are going down. Currently there is \$32 million not allocated to any projects. This report is to track the money. Mr. May explained a report listing expenditures and the projects the funds were spent on as well as a report with the original budget and revised budget. Commissioner Shaheen said the report was very helpful and he would like to see it on Court every quarter. (Time: 2:50 p.m.)

Items 7 and 8 were discussed together. Camp Director Neal Rosenbaum stated the process for updating the beds and mattresses began in April 2010. Following survey results from guests, a large portion of the evaluations cite the beds as a negative factor after using the facility. The beds were designed as a youth bed for a detention center. Commissioner Shaheen said the beds are not that old. He visited the camp and stated he's seen worse beds at other facilities.

Commissioner Jaynes said he would support the request. Commissioner Webb said he also visited the camp. He laid in a bed and, based on its size, it would be impossible for him to sleep in. He understands Commissioner Shaheen's concerns on the financial side. He supported the request with one caveat. He has a concern whether the new foam is sufficient to stop complaints from adult guests. Following discussion, Commissioner Jaynes made a motion to approve items 7 and 8. (Time: 2:26 p.m.)

9. Al-34714 2012 Primary Election Calendar, Administrative Services.

Sharon Rowe, Elections Administrator, said the primary is scheduled for April 3rd. Ms. Rowe said they are waiting to see if that will hold, if the deadlines for functions that need to be completed for wrapping up redistricting can be accomplished in that time frame. They are looking at eleven weeks needed on the timeline to accomplish all those things. Ms. Rowe was involved in a telephone conversation with several county organizations and working with counties interested in providing information on the challenges they face on deadline changes. They have shown their support by proposing modification on the deadlines and changes in the schedule itself without changing the date of the election. Collin County redrew the Commissioners' precinct lines, and the Justices of the Peace and Constables which were affected by those precinct lines. They are waiting to see which lines will be affected. Judge Self asked if the county can meet the deadlines under the Court-ordered maps. Ms. Rowe said she doesn't see how we could.

For the April 3<sup>rd</sup> election, every day that is delayed in making a decision makes it harder and harder to comply and meet those deadlines. (Time: 2:55 p.m.)

10. <u>AI-34596</u> Tyler Odyssey Judge Edition software which includes: Amendment No. 6 to the TechShare Resource Sharing Addendum Common Integrated Justice System (CIJS) Court Administration with the Texas Conference of Urban Counties, End User License Agreement and Professional Services Agreement with Tyler Technologies, hardware associated with the project, budget amendment in the amount of \$169,952 and further authorize the County Judge to finalize and execute same, Information Technology.

Caren Skipworth, CIO, said this item was budgeted in the FY2012 budget. She was requested to bring it back to the judges to discuss agreement and use of the product before purchasing it. Administrative Judges Mason and Rusch said they will put it in every court including the auxiliary courts for visiting judges to start working so they can reduce the number of paper file cases in the courtrooms. It will not eliminate all papers; some must be printed for signature, but it will significantly reduce the amount of paper in a case file jacket for the judges. Ms. Skipworth explained the benefits and said she was requesting permission to move forward with this project. Commissioner Shaheen was torn because the technology that has been implemented so far has not been widely adopted by the judges. Now they want to invest more money. History tells him if you don't use the earlier version of technology, you won't use secondary versions. Ms. Skipworth said this product is just for judges, not for the clerk's office. Judge Self saw a demonstration. He thought it looked user friendly. Ms. Skipworth said all the judges have agreed to use it because it will help them maintain their docket. (Time: 3:02 p.m.)

Commissioner Jaynes asked that this item be placed back on the agenda. He stated after reading the policy and looking at it for over a year, he is comfortable with the policy as is and he made a motion to approve. Commissioner Shaheen stated he is also comfortable with the policy and he seconded the motion.

Commissioner Williams thought a number of issues remained, particularly with the wording. The Commissioner went through the policy and stated her concerns. There was extensive discussion among Court members and Mr. Bilyeu regarding her concerns, including discussion of participation requirements, 4a: "the County's participation percentage may not exceed the City's participation percentage when all

City tax revenues (property and sales taxes excluding Community Development Corporation and Economic Development corporation rebates) are calculated within the TIRZ." Following discussion, Judge Self itemized the five changes discussed: definition of "applicant"; definition of "project plan"; adding the word "category" to project specific participation; all County participation must be for Project Specific Categories; and County participation must be governed by an Interlocal Agreement executed by the municipality and County formalizing the terms and condition of participation.

Commissioner Jaynes modified his motion to include the items discussed, but he wanted the EDC and CDC to remain unchanged. (Time: 2:18 p.m.)

## 12. Al-34692 Personnel Changes, Human Resources.

Judge Self asked District Clerk Andrea Stroh Thompson and Human Resources Director Cynthia Jacobson to come forward. There was a brief discussion of personnel changes but Judge Self wanted to discuss the position of Chief Deputy in the District Clerk's office. Staff was recommending an 8% increase for the individual hired for this position rather than the standard 5% as set forth in policy. Judge Self said he understands that Ms. Thompson came into a difficult position but he felt this would be setting a precedent. Ms. Thompson stated she understands precedent, but feels her position is unprecedented. Her office had the removal of the top three positions. The number two spot is very important and will be as involved as Ms. Thompson. She thought it was an opportunity to elevate the position to what it could be rather than what is has been. The individual hired has a Master's degree in Public Administration, a paralegal certificate, and a grant writing certificate. The request is 2.75% over standard.

Commissioner Williams said she thinks it's critical that our new District Clerk get a team in place that she is comfortable with and that can deal with the numerous challenges that office has to deal with. The Commissioner supported the request. Judge Self said a team would be put in place in any event. The extra 2.75% is not contingent on this individual coming or not. Commissioner Jaynes asked Ms. Thompson if she will do the same with her number three person. Ms. Thompson said it was not her intention but she is evaluating every position. The Court had concerns about financial positions being filled by people without financial backgrounds. Ms. Thompson said she would be evaluating those positions also.

Judge Self again asked about precedent because of the two positions that are considered like positions. Commissioner Williams said precedent doesn't occur until you make a second vote. The only time precedent is set is if the Court doesn't have the fortitude to say no. Ms. Jacobson said HR always recommends 5%; after that, it is a Court decision. Commissioner Shaheen had a problem with deviating from policy. Commissioner Webb said he was torn. He did not realize the differential between this position and the two like positions was so severe. He's concerned that the extra \$2,000 will cause ill will. Ms. Thompson asked the court to consider the fact that the position this individual is leaving had a phone; this new position does not. Caren Skipworth, IT Director, said a phone could be provided.

Commissioner Webb made a motion to approve the 5% increase and a phone allocation. Judge Self noted the Court would be voting on all other personnel changes listed as well. (Time: 2:44 p.m.)
