District Clerk Andrea Stroh Thompson came forward with an update on an audit issue dating back to 2008. A discrepancy of over \$44,000 has been cleared up, and it is down to just over \$800. The \$800 represents smaller issues that predated Odyssey and they have agreed with the Auditor's Office to let it go. Also, Ms. Thompson's staff is required to have passport training once a year. Previously that training required them to travel to Dallas. Ms. Thompson announced they have worked out an arrangement for the training to be brought to them. They will budget for that accordingly this year. The purpose of the grant is to hire a crime victim advocate who is able to go out to crime scenes to assist victims and their families. Commissioner Shaheen said we will be partnering with the City of Frisco on the funding aspect but the position would be countywide. Deputy Allen said the City of Frisco would be employing a full-time employee who would be dedicating half their time to us. Commissioner Jaynes doesn't understand why a Frisco employee is doing that. He asked about the difference between this position and a department chaplain. Deputy Allen said a chaplain is not trained in getting people compensation packages if they are needed. Deputy Allen answered further questions from Court members. Monika Arris, Budget, said this is a request to apply for the grant. If approved, it will be brought back in the 2013 budget process. Commissioner Shaheen said he is in favor of moving forward with this. Judge Self noted as a point to taxpayers, there are a lot of federal dollars floating around. Commissioner Williams doesn't have a problem with letting them apply for the grant but Commissioner Webb was not willing to push it off. He thinks it's a continuing expansion. He wants to cut it off. Commissioner Webb made a motion to deny the request for joint grant application. Judge Self seconded.

GENERAL DISCUSSION

5. <u>AI-34719</u> Amend the FY2012 Fee Schedule to include an agricultural exempt burn permit, Fire Marshal.

Judge Self stated Fire Marshal Michael Smith was asked to return before the Court with an amended fee schedule which is set at the 50 acre limit. Fire Marshal Smith stated he was asked to come up with a definition to meet the agricultural needs of the farming community. A citizen by the name of Claude Frazier spoke in opposition to the burn ban permit at the last meeting. Fire Marshal Smith solicited help from Mr. Frazier in forming the new exempt free burn permit. Mr. Frazier thought it was important to set a figure on acreage that would meet the definition for agricultural but the number is up to the Court to decide. Permits help with knowing where people are burning. Fire Marshal Smith said the permitting process is working because volunteers do not have to respond to calls for illegal burns because dispatch can verify burns with callers. Commissioner Jaynes said he thinks 50 acres is high. Commissioner Williams thinks there needs to be some minimum. She was happy with 50 acres.

Commissioner Jaynes said he would be more comfortable with five. Commissioner Webb was not as comfortable with five but he's more concerned with farmers who have contiguous land. Judge Self said his point has not changed. If a person has an agricultural exemption, why do we need a certain number of acres. Discussion followed among Court members and Fire Marshal Smith as to number of acres and what constitutes pile size. Commissioner Webb wanted to remove the last sentence in the application under "General" which reads: "For agriculture exempt burning status there must be a minimum of fifty acres of contiguous agriculture land." Commissioner Webb also pointed out a typo for the word "Notification". With those changes, Commissioner Webb made a motion to approve. (Time: 2:47 p.m.)

Mr. Sanders stated the City Council has instructed him to indicate they are willing to redirect or forego bond money that has been pledged for Anna projects. Judge Self asked if there were any public comments on this item. Jim Cunningham, Councilman, City of Fairview, thanked the Court for putting the item on the agenda. Mr.

Cunningham stated people in that area would like to see this right of way go back under their town's control.

Judge Self asked for input from the Court. Commissioner Williams said up until January 21st a portion of Fairview was in her precinct. She doesn't think the discussion needs to be about the merits of the roadway itself. The roadway is within the City of Fairview. To put a roadway there we need their participation. The Commissioner wants the Court to release the right-of-way back to the city. Commissioner Jaynes agreed. He asked what the process is if the Court decides to do this. Frank Ybarbo, Purchasing, said the Court could declare that property surplus and transfer ownership over to the city based on fair market value. The County would have to get an appraisal and sell it back to them.
