1. Judge Self called to order the meeting of the Collin County Commissioners' Court at 1:30 p.m. and recessed the meeting at 2:18 p.m.

President Self called to order the meeting of the <u>Collin County Health Care</u> <u>Foundation</u> at 2:18 p.m. and adjourned the meeting at 2:18 p.m.

President Self called to order the meeting of the <u>Collin County Toll Road Authority</u> at 2:18 p.m. and adjourned the meeting at 2:18 p.m. The meeting of the <u>Collin County</u> Commissioners' Court was reconvened.

Commissioner Webb noted the County is about to spend \$33,000 for a postage machine. He had a question about increased maintenance costs. In the last 3 1/2 years the maintenance costs have exceeded the cost of buying a new machine. In 2007 the County paid \$15,000 for maintenance of a postage machine, which does not include postage. The Commissioner wanted to know if the County gets maintenance agreements on these machines. Monika Arris, Budget, replied yes, and the agreements have an increase that goes in every year. Commissioner Webb wanted to look into how this works. Commissioner Shaheen said there are companies that do this as a service so we wouldn't have to have employees and capital expenditures. He asked if it would make sense to use an outside company. Bill Bilyeu, Administrative Services, said we can look into it. Tax statements are handled that way. Commissioner Shaheen would like to see if an outside entity could save the County money. (Time: 2:16 p.m.)

GENERAL DISCUSSION

5. <u>AI-34876</u> City of Farmersville Tax Increment Reinvestment Zone along the US 380 corridor, Budget.

Farmersville Mayor Joe Helmberger came forward requesting the formation of a TIRZ along the US 380 corridor in Farmersville from Lake Lavon to the Hunt County line in order to stimulate economic growth. Farmersville needs the Court's buy in in order to complete the creation of this TIRZ.

Larry Cline from Schrader and Cline was present with a presentation showing the proposed reinvestment zone for the City of Farmersville. Mr. Cline explained the various tracts and proposed development located within the TIRZ. Over the next 30 years this would generate approximately \$340 million of new development.

Commissioner Webb had questions about public improvements and roadways. His questions related to the County's share which is approximately \$6 million. The Commissioner wanted assurance that the expenditures first be allocated for roads and storm sewers. If the projections are substantially off, he wanted to be sure the allocations would go to those types of improvements versus the money going to something like a community center. Commissioner Webb also wanted assurance that everything that has been submitted complies with the recently adopted TIRZ policy. Mr. Bilyeu said the City of Farmersville has been very accommodating; everything complies with the County's recently adopted policy.

Commissioner Webb made a motion to approve conditioned upon an acceptable Interlocal Agreement (ILA) being presented to the Court that sets forth all of the conditions and approvals of this project, including what happens to the \$9 million of contingency. Commissioner Jaynes stated he thinks development will improve the quality of life and economic development. (Time: 1:54 p.m.)

Following the vote, Mr. Bilyeu said the Court needed to appoint two members to participate in ILA drafting. Commissioner Jaynes volunteered. Commissioner Webb made a motion to appoint Commissioner Jaynes to the ILA Board. (Time: 1:54 p.m.)

6. <u>AI-34875</u> Policy for the use of discretionary funds from the 2007 Bond Election, Administrative Services.

Judge Self stated this discussion would be for the use of discretionary funds from both the 2003 and 2007 bond elections. He asked Ms. Arris how the funds were divided since the County never had a real policy. The funds can be saved for a big project or divided up by precinct. Ms. Arris informed the Judge that savings have traditionally been kept in the city in which it was saved. Ms. Arris said the 2007 bond sale authorized \$15 million in discretionary funds; to date only \$545,000 has been sold. More than likely we will sell some discretionary in 2012; the planned bond sale is in April. About \$3.3 million has come in from projects that were under budget and that money has been swept back in from savings. Ms. Arris had a handout for the Court which she explained to Court members and the audience. Bill Bilyeu, Administrative Services, said in the past projects were looked at on a case by case basis. A project can be budgeted at a certain amount but discretionary money had to be added for cost increases. Commissioner Jaynes has been involved in three different bond elections and he feels the current policy works. In the 2007 bond election voters voted knowing in the past we've used this approach. The Commissioner thinks we would be pulling back on our word to the voters because that's not the way it was presented to them. Judge Self said the Court can move bond money to any project legally. Commissioner Jaynes said giving commissioners their own separate discretionary money was not what was presented to voters. Commissioner Webb said since his precinct has zero dollars in allocations for discretionary monies, he would like to have some ability if one of his two cities came to him with a project. He would like to see some amount that he could commit. Discussion followed among Court members. Commissioner Williams thinks there are valid reasons to have a specific amount of dollars that each commissioner can feel confident is going to be available. It's her preference. Judge Self said a halfway measure would be to receive a report every time a Commissioner has spent something. Commissioner Javnes wants to stick by the promise the Court made to voters in 2007. Commissioner Shaheen wanted to stay with the current policy but track it on a precinct by precinct basis. He won't support giving it up.

Following further discussion, Commissioner Shaheen made a motion to track every time we get a project so everybody can see what has happened. Commissioner Jaynes seconded. Judge Self said he will not call for a vote because he's not going to force something that the Commissioners will not agree on. Commissioner Jaynes withdrew

his second but he likes the idea of keeping up for transparency. Commissioner Shaheen said not voting on it keeps it status quo and the Court can ask for reporting. Judge Self recommended pulling the motion and he asked Ms. Arris to track discretionary spending by precinct. (Time: 2:09 p.m.)

7. <u>AI-34874</u> 2007 Discretionary Road Bonds for Woodbridge Parkway and budget amendment in the amount of \$3,514,949 for same, Administrative Services.

Commissioner Williams lead this discussion. Woodbridge Parkway is partially in the City of Sachse and partially in the City of Wylie. It's on the County's thoroughfare plan and it is a critical roadway for both cities. The Commissioner stated imminent development would occur if the roadway were to go forward. The Court had resolutions from both cities as well as letters from their Economic Development Corporations addressing the importance of this roadway. Commissioner Williams asked the Court to begin using discretionary dollars available to fund 50% of this roadway since it is on the thoroughfare plan.

Sachse Mayor Mike Felix came forward. He said this project is one of the most important projects that he's seen processed in quite a while. The Mayor stated this is a very important project both economically and to their education system and schools. The roadway will make the bus routes easier and safer. Mayor Felix asked the Court to consider today's item. Judge Self asked if the City of Sachse has \$2.2 - \$2.3 million available for the match. Mayor Felix replied yes and said he can provide the breakdown if needed. Commissioner Williams said both the City of Sachse and the City of Wylie have their matching dollars. Moving forward on this resolves a number of outstanding issues.

Commissioner Williams reiterated her motion to use discretionary dollars currently on hand to fund 50% of Woodbridge Parkway.

Monika Arris, Budget, stated she would like to pull the budget adjustment off of the agenda until they receive the Interlocal Agreement from the city. At that time they will allocate the dollars. The city will need the right-of-way first and then they will come back a few months later to assign the construction dollars.

Judge Self noted the motion includes using savings dollars. Following discussion, Commissioner Jaynes said we are using savings from projects and it has been good management on our part. (Time: 1:39 p.m.)


