**1.** Judge Self called to order the meeting of the Collin County Commissioners' Court at 1:30 p.m.

Judge Self questioned the Motorola equipment asking if the county would be forced to keep it since it is proprietary. Caren Skipworth, IT, came forward to clarify that while the hardware is Motorola, the actual software that it runs is Brazos. Application designers tell their clients what hardware their software will run on; in this case it is Motorola. Unless the application changes what it runs on, she will keep Motorola. These particular devices also provide driver's license swipes and finger or thumb print swipes. A brief discussion followed. Motion to approve item as submitted. (Time: 1: 38 p.m.)

#### **GENERAL DISCUSSION**

**5.** <u>AI-34936</u> Medicaid 1115 Waiver, Regional Health Partnership, Administrative Services.

Judge Self introduced State Representative Jodi Laubenberg who came forward to discuss Medicaid Waiver 1115 and its impact on Collin County. Ms. Laubenberg gave comments saying SB 7 which was passed in the last legislative session was intended to put the State Medicaid system into a Manage Care System; so far this has not been the case. Waiver 1115 was submitted in the session before; SB 7 gives the Health and Human Services Commission (HHSC) the authority to start implementing parts of the Waiver. Ms. Laubenberg gave the court an overview of the Waiver which was intended to create research and demonstration projects that states could apply for program flexibility to create new approaches to financing and delivering Medicaid and CHIP.

Even with this, Texas still had to follow federal mandates which did not allow managed care, sliding copays or flexibility in eligibility criteria. The new health care bill will force states to expand eligibility which will essentially bankrupt the state. Under the previous system, county hospitals were getting an additional amount of federal funding or Disproportionate Share Hospital (DHS); they could get more federal dollars through Medicare reimbursements. The approval of Medicaid Waiver 1115 changed the system of Medicare, Medicaid, and Fee for Service. The State of Texas is now going to a Managed Care system. County hospitals became concerned they would lose their federal funding, so to keep them from losing this funding Regional Health Care Partnerships (RHP) were created.

The HHSC decides how to divide the state in various regions without considering demographics or population. Collin County was paired with Dallas County which doesn't make sense. Billy Millwee, who is the person responsible for setting the RHPs will be at the hearing on Wednesday. What Mr. Millwee designs, Commissioner Suehs will ultimately approve which is why it is so important that Collin County engage in the discussion. Ms. Laubenberg was assured that Collin would have influence on how the region is developed.

Ms. Laubenberg continued saying that for the past 10 years she has been in a tug of war with Parkland Hospital, who has been trying to incorporate surrounding counties into a taxing district. In her opinion, the RHPs are setting up future taxing districts for indigent healthcare. If that happens we want to be in a district with counties of the same size and demographics where we can determine our own future. It is critical that the districts are done correctly because once formed, they cannot be changed.

Ms. Laubenberg recommended the Court hire a lobbyist to represent the county taxpayers in Austin regarding this issue. The Commissioners could go to Austin, but they would not be successful. Ms. Laubenberg feels very strongly about the issue and informed the Court they had to have someone representing Collin County involved in the day to day business of the issue.

Judge Self informed the court of a letter which has been signed by the County's four (4) State Representatives and will go to Commissioner Suehs by the end of the day. They have submitted a map to the State that consists of 12 counties. Judge Self and Commissioner Williams will attend the hearing on Wednesday.

Ms. Laubenberg recommended that the Judge and Commissioner be firm when giving their comments at the hearing. She stressed that they make sure that all of the counties are in agreement; if there is even one that does not want to be in the RHP, it would destroy the whole regional plan.

Commissioner Williams thanked Representative Laubenberg for the guidance she has provided regarding the issue. Commissioner Webb also expressed his appreciation for Representative Laubenberg's efforts and her comments on hiring a lobbyist. (Time: 2:00 pm.)

Commissioner Shaheen gave a briefing on a meeting he attended in East Texas regarding the 1115 Waiver. Some of the counties that Collin County is interested in a forming regional partnership with also attended; they included Lamar, Delta, and Hopkins Counties. The Commissioner reported having a good dialog with all the counties with the exception of Lamar County; he was unable to meet with their County Judge. In general all appeared receptive to joining a region with Collin County. A brief discussion followed.

Bill Bilyeu, County Administrator, came forward informing the court that he talked to the county's attorney who attended a meeting on Friday which was in RHP 8. The Brazos River Valley COG represents eight counties; Commissioner Millwee attended their meeting. Some of the points of interest included Commissioner Millwee saying that there would always be some administrative funds for the HUB of the region. RHP 8 will try to use their COG as the HUB with assistance from Texas A&M University's Health Science School. The eight counties that make up that COG have all passed resolutions to stay together. Commissioner Millwee stated that the final decision on the RHPs will be made by the end of this month. A county who chooses not to participate will be placed in an RHP. Discussion regarding Collin County's options followed. (Time: 2:15 p.m.)
