#### **GENERAL DISCUSSION**

**5.** <u>AI-35050</u> Collin County Mobility Plan Update, approval of an Engineering Services Agreement with Jacobs Engineering Group, Inc. for Professional Services, Engineering: Mobility Plan Update (RFQ No. 06207-11) and further authorize the Purchasing Agent to finalize and execute same, Engineering.

Tracy Homfeld and Ruben Delgado, Engineering, came forward. Mr. Delgado said one of Collin County's strengths is they have had a thoroughfare plan since 1981-1982. By way of background, Mr. Delgado stated following authorization by the Commissioners' Court several months ago, the Engineering Department went through the Planning Board, the Planning Board looked at the scope of work, and ultimately Jacobs Engineering was selected to proceed with a cost proposal. Ms. Homfeld presented the final proposal for the Court's consideration.

Ms. Homfeld had a Power Point presentation on the 2012-2013 Collin County Mobility Plan (CCMP) update. The last mobility plan update was prepared in 2006-2007. CCMP is a comprehensive multi-modal plan for transportation systems that will serve the mobility needs of the county residents and guide major transportation investments. The reasons for the updated CCMP are: a guide for property owners and developers, to determine future travel demand and needs, identify future roadway locations and planned improvements, efficiently utilize limited resources, preserve corridors needed for future growth, coordinate planning among municipalities, and be a guide for future transportation bond programs.

Some of the changes since 2007: they are extending their planning horizon year from 2030 to 2035; they are changing density and distribution of development; completed road improvements, such as SH121, US75/SR121 interchange, extension of DNT and US 380 widening; changing economic conditions and planned projects removed or delayed. We've been fortunate to have the Highway 121 RTR funds which have allowed construction of many projects. One of the main components of a fiscally constrained plan is that it will be a fiscal analysis that will develop a financial achievable plan that is consistent with COG (Council of Governments), TxDOT, and FHWA (Federal Highway Administration) financial requirements.

Continuing with her presentation, Ms. Homfeld presented a slide which outlined the process flowchart of what Jacobs would be doing in their planning process. A major component is public input. There will be many opportunities for public and community stakeholders to offer input. Jacobs will hold bi-monthly meetings with the Collin County Planning Board. Jacobs will participate in up to nine Planning Board meetings and there will be two countywide stakeholder workshops. The Planning Board and other county officials will be invited to participate in these workshops. There will be agency coordination meetings with every municipality in Collin County. A total of 20 meetings is anticipated. Jacobs anticipates up to four Commissioners' Court meetings for briefings and adoption of final plans.

Ms. Homfeld next presented the plan development schedule and then moved on to cost reduction included. Original proposed cost was \$725,437, and after negotiations it was reduced to \$535,035. She enumerated items removed from the scope for the cost savings. Ms. Homfeld answered questions from Court members. Commissioner Williams asked about reducing the number of stakeholder workshops as listed in the cost reductions slide. The Commissioner thinks we need a couple more meetings, particularly with the eastern side of the county so you can get a good grasp of the needs of those communities. Discussion continued about the numbers and locations of meetings. Mr. Delgado suggested adding an addendum to the contract to include more meetings.

Judge Self stated we need to use this opportunity to address some of our major issues with the federal government, including bike paths that must be put on every highway. Until 2035 we'll be charged if we execute this plan to spend millions of dollars on bike paths. Mr. Delgado introduced Clarence Doherty from Jacobs Engineering.

Following continued discussion, Commissioner Webb made a motion to approve; Commissioner Williams seconded with the caveat of two more meetings, one in the northeast and one in the southeast. Judge Self asked Mr. Delgado and Ms. Homfeld to bring back a plan of meetings. (Time: 2:16 p.m.)

## 6. AI-35027 Environmental Enforcement Program update, Public Works.

Jon Kleinheksel, Public Works, came forward with a briefing on the Environmental Enforcement Program. He presented slides depicting common illegal dumpsites containing residential trash, dead animals, large debris fields, and tires. Tires are a growing problem. Illegal dumping costs taxpayers hundreds of thousands of dollars in clean-up costs and many contain hazardous materials and toxic waste. Mr. Kleinheksel listed the solid waste initiatives: PW/CSCD illegal dumpsite clean-up, PW/Inmate program, recycling centers, Collin County Citizen Trash Drop Off Day, Environmental Enforcement (EE) Program, Nuisance Abatement with the Fire Marshal and there are a couple of grants which are pending. Mr. Kleinheksel showed more slides depicting illegal dumping.

In FY2011, the County saved about \$183,000 using CSCD for clean-up. In FY2012 the County saved about \$157,000 using CSCD for clean-up.

Public Works employees fabricated a machine to cut tires in half. They call it the Tire Shark. Last weekend they collected 780 tires on citizen drop-off day. It costs \$31 a ton to dispose of tires. Over 17,000 tires have been halved since 2009. Since the inception of the Tire Shark, Public Works employees have saved the County \$80,000.

Mr. Kleinheksel showed slides depicting nuisance abatements. One particular clean-up cost over \$50,000. Prior to 2009 the County's approach to clean-up was reactionary. Public Works would just clean everything up. The approach now is proactive. Public Works joined forces with the Sheriff's Department and Deputy Lee Howe was appointed to spearhead the project to prevent illegal dumping throughout the County.

Mr. Kleinheksel spoke about continuing education and training, community outreach and judicial system coordination. Eric Nishomoto, Collin County Public Information Officer, helped Public Works receive a grant which they used to shoot a public service TV commercial which reached approximately 1.4 million households. There is a website dedicated to illegal dumping with a hotline to the Sheriff's Office.

Because of the EE Program, Road and Bridge personnel previously occupied with illegal dumpsite clean-up can be reassigned to core road and bridge maintenance functions.

Judge Self asked how many convictions we have had. Rick Allen, Sheriff's Office Chief Deputy, said we haven't corresponded with the JP's to determine what their judgment is on rendering a guilty verdict or the amount of money they have collected in fines or if there's jail time. We can collaborate with them to find out what they're generating. Judge Self said the next public service announcement should say this man went to jail and it should say what the fines are. Judge Self would like to learn those figures. Major Chuck Ruckel said when they started this program, the Commissioners' Court asked them to capture what it costs them to clean up a site and how much they get back from the courts in recovery costs. They had numbers showing what they received back from the courts. They haven't kept records on the number of convictions. Commissioner Jaynes wants to see hard statistics. Chief Allen said they need to meet with the JP's. Commissioner Webb liked the Judge's comment of publicizing enforcement in handcuffs.

Continuing with the presentation, Mr. Kleinheksel said since the program has been in effect 900 illegal dumpsites have been removed. For FY2012 the number has come down another 110. The County inaugurated the EE program with an initial first year investment of \$140,000. The average cost to clean a dumpsite is \$454. With a decline of 900 illegal dumpsites, minus the initial cost of investment, Collin County realizes a monetary savings of \$268,000. Add to that the annual CSCD labor savings and fines/recovery costs, and the total savings is \$457,199.

Judge Self thinks the program is working. The Judge thinks the next step is publicizing those convictions, fees and fines. (Time: 2:40 p.m.)

Judge Self had an update on the Medicaid 1115 Waiver. The Judge said there is going to be another draft map out on the 25th. They are confident that Collin County will be in a separate RHP from Dallas County. The next conference call is April 17th at 10:30 locally and there will be a statewide conference call at 2:30. Judge Self said this is solidifying. (Time: 2:42 p.m.)

Commissioner Webb attended the RTC meeting last Thursday. He gave the court agenda and his notes, along with blue sheets, to Court members. The Commissioner highlighted the parts of the meeting pertaining to Collin County. Items discussed included an emergency loan to NETEX (Northeast Texas Rural Rail Transportation District); the use of federal money for low income people to help fund their ability to use transit to go to outlying areas for jobs; proposed allocation of \$600 million of additional funding to this region; and TxDOT applying additional funds to do more funding for US 75 between 275, north of Melissa Road, and from north of Melissa Road to the Outer Loop. It was an additional \$12 million. (Time: 2:57 p.m.)

Sheriff Box is providing input. Commissioner Jaynes asked if it has to be elected officials on these committees. Commissioner Shaheen said he would have to find out. The Commissioners discussed the various committees and what they would volunteer for. (Time: 3:01 p.m.)


