Commissioner Webb asked about change order no. 5. Facilities staff was concerned about the water line. The Commissioner asked why we aren't addressing the concerns vs. putting in a pressure valve and a camera. And how much is it going to cost to alleviate the concern? Bill Burke, Project Manager, said at this time we don't know if the concern is an actual problem or not and he explained the issue. Commissioner Webb said the County has spent a lot of money on this water line. If this is a valid concern, the Commissioner wanted to make sure the County has recourse. Commissioner Webb asked Mr. Burke to keep the Court advised. Judge Self was concerned about the 15.67% of the contract, and he asked Bill Bilyeu, Administrative Services, to add that to future agenda items. 15.67% of the contract is too much in change orders. Commissioner Jaynes asked what is normal. Mr. Burke said normally with large projects with the County they keep them below 3%. (Time: 3:22 p.m.)

Judge John Roach, local administrative judge, came forward to address this item. Judge Roach started by thanking representatives from LifePath, CSCD and the Sheriff's office who were present in the courtroom. The Judge also thanked staff from the District and County courts for their cooperation with the Sheriff's office and other mental health professionals.

The focus of this program is to improve the quality of representation to indigent defendants with mental illnesses and to seek solutions to get and keep mentally ill defendants out of the criminal justice system. Judge Roach noted the Commissioners' Court is focused to the taxpavers of Collin County and how the investment today will help save money and make things more efficient in the county. It's also important to focus on the core function of government which is community safety. When talking about mental illness in the justice system, it's usually for somebody who has been charged with a crime and the question for the criminal justice system is whether that person is competent to stand trial. If they are not, the process ends until that person gains competency. Individuals whose competency is in question remain in county jail until a bed opens up in a state mental hospital. This waiting time is very expensive. Currently 39 inmates with some form of mental illness are in our jail. Additionally there are 16 seriously mentally ill inmates with an Access 1 mental diagnosis. It costs \$200 per day to house a seriously mentally ill inmate vs. an average of \$79 a day for a regular inmate. The increase is due to costs for medication, extra guards, and the general havoc created in the jail facility because of the actions of a mentally ill inmate. In Collin County the average stay of a mentally ill inmate is 430% longer, or 213 days for a mentally ill inmate vs. 49 days for a regular inmate. The cost for the 16 seriously mentally ill inmates currently housed is about \$708,800. Over the past 2.5 years inmates found to be incompetent and waiting to be transported to mental health facilities have cost the taxpayers of Collin County in excess of \$1.9 million. The cost of housing the other 39 mentally ill inmates is about \$350,000.

The benefit of this grant is it will lay the foundation to begin competency restoration in Collin County once we find it to be an issue. Instead of the inmate sitting here in jail waiting to be transferred to the State, we can begin that process. Another pressing issue is the action of a State District Judge in Austin. This Judge was challenged with a case where an inmate who had been housed in Travis County complained that their constitutional rights were violated because they were held in a county jail without trial while waiting to be moved to a mental health facility to restore their competency. The Judge said it is against their constitutional rights to be held without a trial in anticipation of them being sent to a hospital. She ordered that the state provide beds for mentally ill patients all across the State of Texas by June 1st. If they don't, the Judge can either hold the state in contempt or she can release all the mentally ill inmates.

Judge Roach stated that will create another problem. If the District Judge orders the release of all these inmates, what do we do as a community? He thinks there are people waiting to regain competency that don't need to be in the jail system. They can be at home with their family but they can't be released because we have no one to supervise them. Probation cannot monitor them because they haven't been convicted of a crime.

Under this grant we would have a director of this indigent defense program and have a case worker, social worker and support staff to make sure these individuals get the treatment they need to get processed through the criminal justice system. The grant also focuses on attorney representation. This would allow us to create an indigent defense mental health attorney program for attorneys that are specially trained to handle these types of cases in order to move these defendants more effectively through the criminal justice system.

Judge Weldon Copeland spoke next. Judge Copeland said when dealing with mentally ill people, they go down before they come back up. With this program, we should be able to treat people before they deteriorate further. The Judge gave an example of three people who were in the county jail for a total of over 150 days for minor issues. The lawyers representing these three people did not know they were entitled to a personal bond. It cost the county over \$10,000 to house these three people. Judge Copeland said we can't educate 500 attorneys but we can educate a dozen.

Judge Self asked if the intent of the program was to treat them outside of the jail with non-profit organizations. Judge Copeland said yes. Commissioner Jaynes asked if we have the matching funds of almost \$63,000. Monika Arris, Budget, said the grant period is October 1, 2012, through September 30, 2013, so if awarded, it will be put in the 2013 budget. Commissioner Webb wanted to look at it at the end of the year to see if we are making progress.

Commissioner Shaheen asked if this is the right approach. He was interested in taking a look at how we handle mental health cases today and seeing if we're not better off tweaking what we do today rather than putting in a whole new infrastructure with an administrator, case workers and administrative support.

Judge Self asked Chief Randy Clark to approach. He asked why a mentally ill person stays so long in jail before the jail contract identifies them as a mental health patient. Chief Clark said they are identified within a week, but the problem is beyond the control of the Sheriff. As the judges have pointed out, attorneys are appointed that have no experience with mentally ill patients.

Commissioner Shaheen recommended that the Court approve submission of the grant application; they would have to come to Court one more time to accept the funds. The Commissioner wants to get a group together to take a look at what we are doing today and how far off we are from the objectives we are trying to reach. Judge Roach said there are some things we can do without this grant. Discussion followed.

Commissioner Jaynes seconded the motion. Commissioner Shaheen amended his motion to have Judge Copeland head up that group.

Commissioner Jaynes noted Texas ranks 50th in the nation for per capita spending on mental health. Judge Self is optimistic about this grant. He thinks the County will save a lot of money.

Commissioner Shaheen asked Judge Copeland to come back with an interim report. Judge Copeland said he and Judge Roach will come back together. (Time: 2:04 p.m.)

# 6. Al-35051 Bond presentation, Budget.

Monika Arris, Budget, had a Power Point on the April 2012 Collin County Bond Update. The presentation started with older bond issues prior to 2003. \$1.4 million was budgeted and allocated on various projects. \$1.3 million is remaining on outdoor camp projects and \$76,500 is remaining on road projects. Ms. Arris reviewed tax notes, or short-term debt, from 1996 to 2006. Projects included court imaging, web project, fiber project, VoIP phone system, and currently the ERP and judicial system. Tax notes outstanding projects, \$9.8 million was budgeted and allocated to projects. \$3.6 million was allocated to the ERP/HR project and \$5 million was allocated to CJIS. \$2.3 million is the total in contingency.

Ms. Arris presented a history of the 2003 voter authorization. All bonds authorized in the 2003 election were sold over five years. Outstanding projects were itemized. Of the \$9.2 million budgeted and allocated, \$8.7 million remains on various roads projects, \$172,000 remains in contingency for roads and \$995,000 remains in contingency for open space.

Moving on to the 2007 bond authorization, Ms. Arris said voters approved \$328 million in bonds and she presented a breakdown of how the money was allocated to various cities. Facilities bonds will fund expansion of the new courthouse and juvenile alternative education facility. Expansions of the juvenile detention facility and adult minimum security detention facility have been pushed off. \$17 million was authorized for parks and open space bonds with a plan to issue those over five years. Ms. Arris presented a breakdown by percentage of the funds awarded to various cities within Collin County. The 2007 bond authorization slide showed they started selling bonds in 2008. Projections go out to 2018. Of 2007 money that's currently been sold, \$43.5 million was budgeted and allocated on 2007 projects for various different cities throughout the county.

2012 requested bonds: \$31 million for transportation funding to be spread throughout various cities; \$2.5 million for parks and open space funding for the grant program. \$1.4 million of contingency discussed previously is to be used for Myers Park Amphitheater and the Trail/Bridge placement between the Administration Building and the Courthouse. The meeting with Central Appraisal District was the end of March. The estimated early preliminary appraised value has an increase of 0.4% over last year but the certified estimate is not due until April 30.

The request today is the approval to authorize a bond sale totaling \$33.5 million: \$31 million in road bonds and \$2.5 million in park and open space. Also, approval to authorize advanced refunding on eligible portions of both the 2004 and 2005 unlimited and limited tax issues.

David Medanich, First Southwest, came forward with a presentation entitled Refunding Discussion. Today's presentation was the same as what was presented to the Court last week with a few changes. The first slide showed interest rates going up, but now they've come down. The bonds considered for refunding are both limited and unlimited tax bonds. Mr. Medanich explained the refunding opportunity and a cash flow savings analysis. The rate for the unlimited tax old bonds is about 4.8%. If the Court approves the refunding, the rate for the new bonds is 2.5%. The savings on the unlimited bonds is about \$160,000 per year beginning in 2013. Mr. Medanich said the County's credit is the best you can have. He intends to come back to court on May 14<sup>th</sup> with a firm transaction. It takes about 30-45 days to go through the attorney general's office.

Judge Self asked for any questions on the refunding. Commissioner Webb had a question on the schedule of the bond sale this year. Judge Self asked for a vote. Commissioner Webb made a motion to approve the refunding. (Time: 2:43 p.m.)

Moving on to a discussion on open space and parks, Commissioner Webb asked if we were to sell an extra \$1 million of open space, would that have a material impact on the tax rate. Ms. Arris said it will increase it slightly. Commissioner Webb said we have parks owned by the county. He would like to see if we will improve them and move them forward. The Commissioner said he is working on a presentation with Jeff Durham about updating Myers Park. He would like to consider authorizing \$3.5 million for open space instead of \$2.5 million. Commissioner Jaynes agreed with Commissioner Webb. He said we've always neglected our own facilities for open space. There was discussion on whether to sell \$2.5 million or \$3.5 million for open space.

Judge Self asked Mr. Medanich to come up with an estimated tax rate if \$1 million was added. The Judge presented a chart which estimated we will get 3.35% interest this year, 5% next year and 5.5% after that. If we sell \$33.5 million this year and then we sell \$36.5 million in two years, the difference in the payback amount is \$46 million vs. \$60 million. Judge Self asked Tracy Homfeld, Engineering, to come forward. Ms. Homfeld said we don't have any projects currently that we need money on.

After lengthy discussion between Court members, Ms. Arris, Ms. Homfeld, Mr. Medanich and Mr. Bilyeu, Judge Self recessed the discussion in order to give Mr. Medanich time to answer his question.

The discussion was recessed at 3:01 p.m. and reconvened at 3:28 p.m.

Mr. Medanich, Ms. Arris, and Ms. Homfeld returned to the podium. Ms. Arris said after going through calculations, we can sell an additional \$22.4 million. The question is what to use it on. Judge Self doesn't think we need \$22 million.

Following lengthy discussion, Commissioner Webb made a motion to approve a bond sale of \$40 million: \$33.5 million, plus an extra \$6.5 million for discretionary. Discussion continued. Judge Self noted the motion would be amended to approve the bond sale of \$40 million. \$6.5 million was added in transportation bonds and \$1 million to open space. (Time: 3:43 p.m.)


