GENERAL DISCUSSION

5. <u>AI-35285</u> Medicaid 1115 Waiver, Regional Health Partnership, Administrative Services.

Bill Bilyeu, Administrative Services, came forward with an update. Mr. Bilyeu stated Court members should have received an email today from the state confirming what RHP18 looks like. It's the four counties: Collin, Denton, Grayson and Rockwall, with Collin County being the anchor. The issue now is providing the duties for the anchor. UNT Health Science Center has decided as a school they do not want a contractor to provide these services. Contractors have reached out to Collin County. These contractors have a background in this. There are deadlines coming up: the conference scheduled for June has been moved to August, and there are other things due at the end of August. Public Hearings need to occur before then. We are required to have five projects, but it's possible that could be reduced to two. Mr. Bilyeu is concerned about the timeframe because it's approximately 75 days until the final deadline. He suggested hiring staff. We need to get a contract in place to become operational.

Judge Self stated the other counties took Collin County's feedback form. They're on board and prepared for Collin County to ask them to help pay for it. The conference is in early August and September 1st is the submission date. The Judge said we cannot wait until early August to go down there and have more talks. We need policy discussions on how we are going to approach this. Projects have been identified. Commissioner Williams thinks it's important to go over what the Court discovered during conference calls. If we say we are not going to participate in the programs, the hospitals in Collin County will be penalized by not receiving funding. The Judge stated hospitals in the other counties would be effected as well.

Mr. Bilyeu recommends the Court move quickly. There are private contractors. He prefers to stay inside with UNT. We have a good relationship with them and they are prepared to step up. Judge Self stated this isn't a perfect solution but we could control it better than consultants and limit what we want them to do. Commissioner Williams thinks the timeframe is critical and she wants to see a contract before the Court next week. Commissioner Shaheen was interested in what other alternatives Collin County has. Judge Self said by next week he wanted to see every option available to the County. Commissioner Webb would like to see the dollar costs that go with this. The Commissioner is interested in continuing to push the rural classification if that's possible.

Mr. Bilyeu said the contract with UNT is about to run out. It's \$200,000 and it's pro rated among the counties if we get their participation and hopefully some reimbursement from the Medicaid program. Judge Self said if we get a 40% reimbursement from \$200,000, we're looking at \$120,000 across the RHP and Collin County will be a little more than half. Collin County is looking at no more than \$60,000 to the end of the program which will be towards the end of the year. The Judge stated that's a rough number for Collin County's share.

Following discussion, Judge Self said the best case scenario is the Court will see multiple contracts next week; the worst case is they will see one contract. (Time: 6:29 p.m.)
