A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN INTERLOCAL AGREEMENT WITH COLLIN COUNTY FOR FUNDING THE INTERSECTION CAPACITY IMPROVEMENTS ON VIRGINIA PARKWAY AND ELDORADO PARKWAY

WHEREAS, the City Council of the City of McKinney, Texas, recognizes the need for the construction of Intersection Capacity Improvements on Virginia Parkway and Eldorado Parkway; and

WHEREAS, the City Council of the City of McKinney, Texas, has reviewed an Interlocal Agreement between Collin County, Texas, and the City of McKinney concerning funding for the Intersection Capacity Improvements on Virginia Parkway and Eldorado Parkway.

Section 1. The City Council of the City of McKinney, Texas, hereby authorizes the City Manager to execute an Interlocal Agreement with Collin County for funding the Intersection Capacity Improvements on Virginia Parkway and Eldorado Parkway.

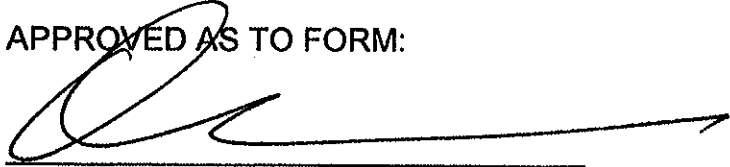
