Jon Kleinheksel, Public Works, came forward with a recap. This agreement was initiated through mutual boundary discussions with each city. Mr. Kleinheksel met with the Mayor of Lowry Crossing and his staff and talked about the mutual boundary program. This proposal evolved into a more all-encompassing repair than just the mutual boundary road. Of the \$778,539.58, \$165,067.55 is designated for mutual boundaries; the remaining amount is earmarked for municipal road projects that are 100% within the limits of Lowry Crossing. Mr. Kleinheksel met with representatives from Lowry Crossing and explained if we move forward with this, they would have to prioritize their city road projects. The County would do one to three roads per year through this agreement so there wouldn't be a big impact on our budget or resources. Mr. Kleinheksel answered questions from Court members. He stated currently there are five cities that the County currently has outstanding city work on. There was a list seven pages long from other cities requesting services.

Commissioner Williams noted this is a critical service for some of our smaller communities who need our assistance.

Mayor Derek Stephens, Lowry Crossing, came forward. The Mayor was happy with the agreement. He stated the bond request is based on a county estimate. The initial request was larger but Lowry Crossing was able to pave their main thoroughfare themselves. They believe it will be more financially responsible for the city and the county to do the project at once. Lowry Crossing has made some of their financial decisions with the hope of reaching an interlocal agreement with the county.

Commissioner Jaynes stated he appreciates the Mayor's work and he made a motion to approve. (Time: 2:28 p.m.)

Commissioner Webb stated since the City of Frisco would not be receiving funds as originally allocated in the FY2013 budget, rather than reallocating Frisco's funds to the other libraries, the Commissioner wanted to reduce the allocation by the amount that would have been paid for Frisco. Commissioner Williams agreed.

Beth Scudder was present to speak on behalf of the library association. Ms. Scudder said last year's funding formula was different. In FY2012, the City of Plano withdrew. At that time, the Court reallocated those resources among the remaining nine libraries. During this year's budget workshop, Ms. Scudder came back and talked about a new funding formula which is based just on the unincorporated areas. Ms. Scudder explained how they arrived at the new formula.

Commissioner Shaheen stated he would prefer to reallocate the dollars. Instead of the county building libraries, we partner with our cities. Following discussion, Judge Self said 41,000 people would still be served. Commissioner Williams would prefer going

forward that we identify how much usage is occurring at the libraries. It's currently based on zip code.

Commissioner Webb said this is not a core function of county government so he would not support reallocating the funds. The Commissioner made a motion not to reallocate. Commissioner Williams seconded. (Time: 2:36 p.m.)

GENERAL DISCUSSION

5. <u>AI-35974</u> **PUBLIC HEARING** – to hear testimony regarding the changes to the Collin County Subdivision regulations and subsequent approval of the changes, Engineering.

Tracy Homfeld, Engineering, came forward. She is bringing this item to Court to make minor changes to the subdivision regulations with regard to the county's storm water program.

Judge Self opened the public hearing at 2:36 p.m. Hearing no comments, the public hearing was closed at 2:36 p.m.

Commissioner Shaheen asked about the naming of roads and making sure there is not a conflict. He asked Ms. Homfeld if that is checked countywide. Ms. Homfeld said she does her check countywide, by first going to the Central Appraisal District and then to the post office. The Commissioner wanted to have a section in the subdivision regulations that applies only to MUDs (Municipal Utility District) and which complied with requirements provided by Commissioners' Court. Ms. Homfeld said the Engineering Department cannot deny or approve a plat, but they can deny a drainage plan or storm water plan. Discussion followed on special districts.

Lot size was discussed for on-site sewage regulations. Commissioner Jaynes asked if a one-acre minimum lot size really meant one acre plus the square footage of the house. Ms. Homfeld said according to on-site sewage regulation, lots utilizing on-site sewage facilities shall provide for a minimum of one acre of useable surface area. If the property has a well, it's 1.5 acres of useable area for lots served by individual water systems. Ms. Homfeld asked to have that included in the regulations. Commissioner Shaheen wanted an addition that street names won't conflict with others in the county.

With those two amendments, Commissioner Williams made a motion to approve. (Time: 2:47 p.m.)

Commissioner Jaynes complimented Public Works for 14 roads which are new construction. A motion was made to approve. (Time: 2:50 p.m.)

(Time: 1:35 p.m.)

Judge Self reconvened the meeting at 2:07 p.m.

Commissioners Jaynes and Williams were not happy with the draft received nor the existing ordinance. Commissioner Williams stated she thinks the Planning Board would be an excellent place to have this vetted and reviewed. Commissioner Shaheen agreed and made a motion to task the County Planning Board with revisiting this court order

and he made a recommendation for a rewrite. Judge Self noted the Planning Board needs to understand the state law since this is an unincorporated area, which is different than cities. Commissioner Webb wanted the Planning Board to have access to county attorney Greg Hudson. (Time: 2:09 p.m.)

Judge Self had public comment cards and called Mayor Joe Teske forward to speak.

Lavon Mayor Joe Teske stated his city borders four or five of the establishments under discussion. He gave an example of one near the Wylie ETJ (Extraterritorial Jurisdiction) which is adjacent to the flood plane for the spillway to Lake Lavon and Lake Ray Hubbard. There are certain rules pertaining to junk yards and how they must drain antifreeze, gasoline and oil. The Mayor had concerns about this particular establishment. Mayor Teske stated he hoped the Court would be more stringent than what is in place right now with regard to junkyards, bodies of water and runoff.

Mia Smith, Councilwoman for the City of Nevada, stated it is the general consensus of the City Council to oppose the building permit for 1500 West FM 6. There is currently a building there. Allowing them to rebuild will allow them to expand and enlarge their current salvage business. Ms. Smith stated we do not need bigger salvage yards. FM 6 is the main roadway to Nevada. To allow more salvage yards will discourage development and decrease property values. The businesses are in the ETJ and will eventually become the city's problem. The City of Nevada wants businesses that will benefit the growth of the city and encourage builders to build more homes. To change the grandfathered laws would affect all cities in Collin County. Continuing, Ms. Smith said if the Court allows a non-conforming use to rebuild, the law is meaningless. Ms. Smith asked the Court to not allow the rebuild permit to 1500 West FM 6, Nevada, Texas. She also asked the Court to not change the rules or change the grandfathered laws or any provisions within the law to allow a non-conforming use to expand, enlarge or rebuild. (Time: 2:13 p.m.)
