3. AI-34769 Fee proposal for the Collin County Outer Loop Segment 3, Administrative Services.

Mr. Delgado informed the Board that during the public hearings for citizen input on the Outer Loop Segment 3 alignment, they were asked by many of the citizens to find another alignment. His department reviewed the scope of work and prepared a proposal for the Board's approval.

Mr. Delgado replied that Collin County was funding this project without assistance from any other entities. Director Jaynes requested assistance from the RTC; Director Webb agreed to approach the committee regarding assisting with the funding of the project. Director Shaheen asked for a report on the people who were contacted. Director Webb will not support the proposal; he thinks there are better alternatives for spending funds. 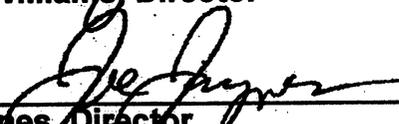

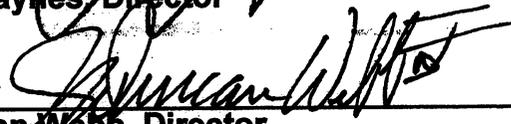
