GENERAL DISCUSSION

3. Receive and File the Monthly Financial Report(s), Auditor:

Candy Blair, Health Care Services, came forward to update the Board on the \$2 million increase in the health care fund. In the summer of 2010 they became aware of an affidavit of support that could be used to screen applicants for eligibility of services. Due to the efforts of the Board, SB 420 was signed and as a result they have seen a savings of \$1.5 million. With the implementation of Project Access they saw an additional savings of \$112,000. They will continue to screen applicants as the state is cutting back on programs. Ms. Blair does not know how the budget cuts will affect her department. They continue to receive 600-800 referrals each month so they will have to watch the applicants carefully.

Project Access will give their annual report to the Board on May 21st; President Self commented that it was a remarkable turnaround. He then mentioned that he has the understanding the rules for the affidavit are being written and asked if the Board needed to participate to they are written correctly. Ms. Blair replied that they have participated and the county attorney has been diligent in sending information. Ms. Blair encouraged the Board to stay active in this as they have met with some opposition at the state level. President Self requested this issue be added to the county legislative agenda. A brief discussion followed.

President Self thanked Ms. Blair for her update and made a motion to accept items 3a through 3e. (Time: 4:15 p.m.)
