Commissioner Shaheen stated this item is an investment in technology through the leadership of the County Clerk. With this technology the County Clerk's office can deposit checks by scanning them and the funds will be available that day. The Commissioner commended the County Clerk and noted the tax assessor is also depositing checks in this manner. He'd like the District Clerk and other departments to look at this technology. Commissioner Shaheen made a motion to approve the budget amendment. Commissioner Williams agrees this is great technology and she thinks it would be useful in smaller departments so there would not be issues with cash handling. The Commissioner stated most banks provide this as a service for those customers who have large deposits and large volume. She was dismayed that the County has to purchase this. The Commissioner requested in the future when the County goes out for bid for financial institutions, that those services be part of our depository agreements. Commissioner Webb agreed and also thinks it's great

technology. Judge Self asked when the ANB contract is up. Jeff May, County Auditor, stated the County was in year two of a four-year contract. Commissioner Shaheen asked how flexible the system would be if the County wanted to make a change to another provider. Mr. May thinks the equipment can be used with another institution. Commissioner Hill asked as this process is being used, are the necessary procedures in place to govern the check handling, safekeeping and ultimate destruction of those checks. Mr. May replied yes; it's currently being done in the tax office. Mr. May will bring Commissioner Williams' concerns to ANB's attention at their next meeting. Judge Self thinks we should make our point now. Mr. Bilyeu stated ANB's business plan doesn't provide for free equipment. It provides for free service. (Time: 1:39 p.m.)

GENERAL DISCUSSION

5. Al-33858 RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb presented the update. It was approved during the RTC monthly meeting that US 75 will now become the highest ranked project that has not been addressed. All future funding will go to that project. The primary focus will be between LBJ up to 121. Additionally, the Commissioner stated he was part of a contentious discussion which ended in a 19-16 vote. The City of Dallas asked the RTC (Regional Transportation Council) to spend \$2 million on a workforce training program. Commissioner Webb and other representatives not connected to the City of Dallas questioned why the RTC was involved in this since it has nothing to do with transportation. The City of Dallas acknowledged the reason they went to the RTC is because they did not want to spend their own \$2 million for the program. The City of Dallas had 19 votes in support of the program and 16 other representatives voted no and lost. Commissioner Webb stated Collin County could use that money, which was labeled surface transportation funds, for projects. The \$2 million for training is being

used to build sidewalks and landscapes in the City of Dallas. Judge Self asked if the RTC has addressed the NTTA/TxDOT project on 360. Commissioner Webb replied yes, there was discussion as part of a presentation. Judge Self asked Commissioner Webb to return with more information on that project. (Time: 1:44 p.m.)

Mr. Bilyeu returned to the podium to update the Court on a conference call. The biggest feedback was UC (Uncompensated Care) payments, which used to be called UPL (Upper Payment Limit). There was a UPL agreement entered into with Tenet Hospital in January 2012. A payment hasn't been made yet. The state has concerns that they won't have enough funding to fund all of the UC projects and they sent out a survey. Collin County is waiting to see what happens and will hopefully make their UC payment to Tenet by the end of February. There will be feedback on our plan in about ten days and we'll have 20 days to respond. The state has approximately 1,200 plans that they are reviewing. Timing is important. (Time: 1:47 p.m.)
