Commissioner Webb said there is one interesting map which shows the congestion levels for DFW vs. Houston. The comparison is striking. (Time: 1:38 p.m.)

# **c. AI-36399** HB 691.

Representative Jodie Laubenberg is interested in this topic but there is no position from her yet. Commissioner Williams added she appreciates the spirit in which this is made. The Commissioner stated while the state will look at the legal issues surrounding this, there are federal protections for these types of facilities. (Time: 1:42 p.m.)

## d. Al-36400 HB 832.

Judge Self wanted to watch this item. HB 832 will allow spraying on abandoned or uninhabited properties with mosquitoes and stagnant water. There is no committee for this item yet. (Time: 1:43 p.m.)

## e. Al-36402 HB 958.

HB 958 is the TCDRS bill that lowers the guaranteed interest from 7% to 5%. Judge Self stated there's lots of conversation on this bill around the state. It does not have a committee. Commissioners' Courts around state are expressing opposition to the bill. Commissioner Shaheen stated he will publicly support this bill. The Commissioner asked if the Court wanted to wait until the bill goes to committee. Commissioner Williams felt certain items are important enough for the Court to take a position early on to try to help them get into committee. Commissioner Shaheen agreed.

Commissioner Hill has a meeting this week with TCDRS to learn more about this item. He stated he is not ready to vote one way or the other. Commissioner Webb also wanted to wait. A brief discussion followed. Commissioner Shaheen questioned whether the County should take tax money to supplement a guarantee from citizens who don't have a guarantee. It was agreed to place this item on the next Court agenda. (Time: 1:47 p.m.)

# **f. AI-36401** HB 960.

The author of HB 960 is State Representative Scott Sanford and the co-sponsor is State Representative Jodie Laubenberg, both from Collin County. The bill has to do with ballot language when you go for a bond election. It currently has no committee. Commissioner Shaheen was fine with the language in the bill but questioned if this is a requirement only of counties. Commissioner Webb had the same question. Following discussion, a motion was made to support this bill with a request to Representative Sanford's office that it include all government entities. (Time: 1:49 p.m.)

Judge Self noted Denton County passed this with a 5-0 vote with no changes in language. They put an additional seat for the cities in their resolution. Commissioner Webb has a problem with our language. He would like to see the population cap of 850,000 removed. Collin County will exceed that in a year and lose their seat on the board.

Judge Self said the advice from our lawyer is the most recent federal decennial census covers us; we get a ten-year grace period regardless. It was recommended we put both limits on to limit potential impact and make this as local a bill as possible. Following discussion, a motion was made to approve the NCTCOG Executive Board membership. # i. Al-36420 HB13

Although this item was not on the original agenda, Judge Self stated he would like to address HB13, a pension transparency bill that already has a committee. The bill was drafted and authored by the Pension Committee Chairman. The bill is about transparency at the Pension Review Board. The Judge recommended the Court support this bill. Following brief discussion, a motion was made to support HB 13. (Time: 1:50 p.m.)

## **COURT ORDER NO. 2013-126-02-18**

Commissioner Williams had additional bills she wanted to bring to the Court's attention. HB 927 is a bill the Commissioners may want to support in advance. It's a voter registration bill that would require anyone being a deputy registrar to live in the state and would also create a fine if a deputy registrar were to register an illegal alien to vote. Judge Self asked that all of these items be put on next weeks' agenda so the Court may review them.

HB 996 allows the electronic delivery of certain documents by the court clerk.

SB 390 is one that makes all fee changes occur on January 1<sup>st</sup> which could help with some of the issues the County has had with fees.

SB 382 prevents counties from disbursing any funds to a person who is delinquent on property tax. Commissioner Williams asked how we would keep track of that. She would like clarification on that item. (Time: 1:55 p.m.)

**9.** Possible future agenda items by Commissioners Court without discussion.

Judge Self directed the Court's attention to his letter to the Governor stating Collin County had to pay \$100,000 for visiting judges' salaries. He questioned whether the County should change the law. Currently a certain amount of money is allocated to Collin County. If we go over that amount, do we shut down a District Court or pay a state salary to keep it going? This item will be placed on the next court agenda.

Judge Self stated the next item for a future court agenda was brought to him by Mr. Bilyeu. The Judicial Compensation Commission has recommended to the legislature that all judges, District Court and above, get a 21.5% pay raise. Judge Self would like to watch this item. (Time: 2:02 p.m.)

The Court did not recess into Executive Session. There being no further business of the Court, Judge Self adjourned the meeting at 2:02 p.m.
