Commissioner Webb questioned a variance in the audit of \$10,058.32. Cost incurred for FY2011 was \$203,734.07, while the amount billed and received was \$193,675.75. The Commissioner asked why there was a shortage in billing, whether that amount can be recovered and how this can be prevented in the future. Jeff May, County Auditor, stated the billing came up short due to benefits, longevity and overtime in the Sheriff's office. The Auditor's office is now preparing billing to send to the Sheriff. This issue has been addressed for the future and will not happen again. Judge Self suggested holding this item. (Time: 9:04 p.m.)

Commissioner Webb questioned why a payment of over \$200,000 received in the Tax Assessor Collector's office in May 2011 was not recorded until September 2011. Mr. May replied it was a reporting error that was brought to the Tax Assessor's attention.

Commissioner Webb's next issue had to do with bonds. Of the 39 contracts and bonds reviewed, nine bonds did not have the same dealer name as the corresponding contracts. The Commissioner recommended doing a full audit of the dealer bonds and subcontractor bonds to find out how much we're missing. Mr. May said this audit was a 100% sample; they only have 39 dealers. Commissioner Webb would like to hear from Mr. Maun.

Commissioner Webb made a motion to accept and file the 3<sup>rd</sup> Quarter FY2011 Audit Results, but wanted the dealer bonds brought current. Mr. May stated his office has emailed Mr. Maun several times but there has been no response. Judge Self recommended redoing the audit if there is not a response from the tax assessor. It was clarified that the tax assessor is responsible if there is a loss. (Time: 9:11 p.m.)

#### **GENERAL DISCUSSION**

**5.** <u>AI-36411</u> Public Hearing - Consideration and any action for the issuance of a "Mass Gathering" permit for the Garden Show event on March 23-24, 2013 in accordance to the Health and Safety Code 751, Fire Marshal.

Bill Bilyeu, Administrative Director, was requesting a public hearing on behalf of the Fire Marshal. This is a request for the issuance of a Mass Gathering permit. A Mass Gathering is an event that lasts over five hours and is attended by 2,500 people, or attended by 500 people with alcohol served. A review must be conducted by the Sheriff, Environmental Health and the Fire Marshal to ensure that safety practices are in place. The event before the Court is the Garden Show. Mr. Bilyeu stated the Master Gardeners have \$1 million in insurance coverage.

Judge Self opened the public hearing at 9:12 p.m. Hearing no comments, the public hearing was closed at 9:12 p.m.

# 6. Al-36413 Estray operations at the Animal Shelter, Administrative Services.

Mr. Bilyeu remained at the podium with a power point presentation entitled "CCAS: Livestock Services". Mr. Bilyeu updated the Court on the bidding process for livestock services and commended Purchasing for their hard work. The request before the Court was to move the livestock area downhill, away from the Animal Shelter buildings, where they would have better drainage to alleviate the problems of flooding and flies. The cost of replicating the livestock yard behind the animal shelter is \$35,000. Money has been set aside in the Permanent Improvement Fund. The estimated annual operating cost of \$31,667 will not change. Judge Self stated he was originally opposed to this, but now supports it because it is a health problem. Commissioner Williams agreed. Following discussion, a motion was made to approve the estray operations at the Animal Shelter. (Time: 9:20 p.m.)

Judge Self asked to hold this item; however, Commissioner Shaheen had a question. The Commissioner asked about the increase in grants from \$3.3 million in FY2001 to \$18.2 million currently. Mr. May replied the numbers are skewed due to grants received from the RTR (Regional Toll Revenue) for the Outer Loop. Commissioner Shaheen asked Mr. May to provide a breakdown of federal grants and Judge Self asked for the benefit of each grant. Mr. May said he would bring that information to a future court. (Time: 9:22 p.m.)

# **8.** <u>AI-36476</u> Designation of Collin County Rural Transit District, Commissioner, Precinct 3.

Commissioner Hill led the discussion to consider a request for approval of the designation of a Rural Transit District for Collin County. In the State of Texas, County Commissioners' Courts are tasked to designate the Rural Transit District (RTD) provider for the county. Collin County Area Regional Transit (CCART) has been that designee. Dallas Area Rapid Transit (DART) and Texoma Area Paratransit System (TAPS) also provide service to Collin County. Commissioner Hill, as liaison for the Commissioners' Court, is asking that TAPS be designated as the RTD.

Commissioner Hill had three criteria to explore when deciding upon the most appropriate RTD: federal grant funding, local match funding and delivery of transportation services. The Commissioner stated since 2009 over \$622,000 in state and federal grant funds were awarded to CCART but never received due to non-utilization and lack of local matching funds. As a result, Collin County has provided less

transit services to our citizens. TAPS, which is based in Grayson County, provides service to six county areas and their fixed-route service has expanded during the same time period.

CCART's ridership has decreased by over 100,000 persons at a time when the county population is increasing. CCART claims local dollars haven't been available to match federal dollars. Last year TAPS overmatched their federal funds by \$400,000.

CCART ratios for operating costs per total miles and per total hours are three times higher than TAPS. TAPS averages 20 times more passengers daily than CCART (521 to 22) while serving a population area one-third the size of CCART. CCART operates at an average of one passenger per day per vehicle for a per passenger cost of \$84.29. Compare that to TAPS which operates at an average of 15 passengers per day per vehicle for a per passenger cost of \$15.01. CCART's failure rate is every 308 miles; TAPS' failure rate is every 28,857 miles.

Brad Underwood, CEO TAPS Public Transit, came forward with a power point presentation. Mr. Underwood had a slide depicting their service area which covers 8,500 square miles. TAPS offers a mix of fixed routes and demand response. In FY2011-2012 they made 316,300 trips. With an anticipated growth rate of 28%, TAPS expects to exceed 400,000 trips for FY2013. Mr. Underwood touched on the service routes offered by TAPS such as airport shuttles and college routes.

Continuing, Mr. Underwood said since 2008 ridership has increased as a whole by 103%. Year to date ridership is increasing at a growth rate of 28%. Federal grants have increased from over \$1 million in 2008 to over \$6 million in 2012. Mr. Underwood explained TAPS' sources of local matches as well as non-traditional match options where a group of partners is brought together. TAPS has a current operating budget of \$10.4 million.

Mr. Underwood remained before the Court and answered questions regarding services offered and partnerships. TAPS has a record of being 87% on time. 90% of their fleet is wheelchair accessible and every driver is certified.

Commissioner Hill stated he has received complaints concerning on-demand calls for CCART. Sometimes passengers must call a week in advance. Mr. Underwood stated TAPS can provide demand response trips the next day. They have eight full-time dispatchers and a dispatcher that works on Saturday. TAPS completes an average of 1,300-1,400 demand response trips per day.

Mr. Underwood was asked about fares. Fares are set by their Board: \$3.00 is the out of county rate; \$2.00 is the in county rate; and \$1.00 is the in city rate. TAPS offers half-price fares for the elderly and disabled.

Commissioner Williams asked about the makeup of the TAPS Board. Mr. Underwood replied there are currently 12 members on the Board but they can have up to 15 members. Every county gets a representative on the Board and every major city in the county gets a representative. Commissioner Hill was concerned that two seats on the Board might not be favorable for Collin County. The Commissioner stated he was relieved to learn that funds are fenced in county to county so that one county could not exert more pressure on the Board.

Following discussion, Mr. Underwood was asked if he sees any obstacles in coming to Collin County such that CCART experiences. Mr. Underwood said no; growing the organization is part of his job. Commissioner Hill did not want service to be interrupted for rural citizens and Commissioner Williams felt with TAPS there was a glaring hole in the southeast area of the county. Mr. Underwood assured the Commissioners that TAPS would work with TxDOT to make sure there wasn't a lapse in service and they would coordinate services with a provider in Lavon. Those are the types of issues they work out on a daily basis.

In conclusion Mr. Underwood stated he has been working on this project for just 45 days. TAPS has acquired 19 CCART units that were taken away for underutilization and given to an organization that would utilize them. Each unit must do a minimum of 10,000 miles per year.

Rose Lee is with First Transit. She came forward to address the Court. First Transit is under contract with North Central Texas Council of Governments (NCTCOG) to look at the CCART organization. Ms. Lee worked on a program to remove the CCART program from under the Collin County Committee on Aging (CCCOA). Ms. Lee stated she believes misinformation has been brought forth. Her job is one of process: seeing where CCART is, where it wants to go and how to do that.

In 2011 NCTCOG had someone look at the oversights of CCART. NCTCOG also brought forth a Collin County Transportation Needs Assessment. Ms. Lee stated CCART hasn't gone out to look for contractual arrangements. People can't get rides yet nobody locally wants to fund it. That's where her job comes in. Ms. Lee was brought in to get a local match to match federal funding.

Judge Self related the story of a woman who lost her sight in 2009. She called CCART for a ride and was told she would need to make a reservation two weeks in advance at a cost of \$9.00. Ms. Lee said as a result of a project this past year, CCART has changed their reservations from two weeks to four days.

Ms. Lee wanted to remove CCART from CCCOA in order to let local governments see what they have. She has until the end of May to do this appropriately. They are looking at county and city members to be a part of this process. On Friday the Collin County Board had their first meeting and learned from Commissioner Hill that the county was going to change their designation from CCART to TAPS.

Judge Self noted the county's formal designation is still CCART. There is not a new board; there is no formal committee. Following discussion Commissioner Hill stated Ms. Lee was brought in to find the best way to service the needs of Collin County. TAPS could use the needs assessment created by NCTCOG to look at how best to provide service to our county. The question before the Court is which organization is best suited to provide that service. Commissioner Hill is on the nine-member Board and he is recommending TAPS. Ms. Lee is trying to build something from the ground up. Ms. Lee stated there are two issues: one is a designated program and the other is a provider. First Transit is looking at the designated program and the Court is looking at the provider. Discussion continued.

Mayor Brian Loughmiller, McKinney, was the next speaker to address the Court. Mayor Loughmiller stated from the standpoint of the City of McKinney their first priority as a City Council is to talk about providing effective transportation within McKinney and in the McKinney UZA (Urbanized Area). For the City of McKinney that means accountability on the part of the provider. McKinney has been providing matching funds of \$100,000 per year. The Mayor wanted to be sure the Commissioners' Court decision would not impact McKinney's ability to choose an urban provider and to access federal dollars for the McKinney UZA. There was discussion of Board formations and the number of seats available. Mayor Loughmiller understands McKinney's rights and responsibilities. The City can select their own provider or delegate it to another authority. The City of McKinney has not yet made that determination and they do not want a decision by the Commissioners' Court to result in a predetermination of what they do in the urban area.

Commissioner Webb stated he sent an email to COG asking if the Commissioners' Court has the power to designate who the City of McKinney uses as a public transit provider. The Commissioner was told the County cannot designate who McKinney choses but they can affect the choices the city has. If the County selects TAPS, then the County has made TAPS the mechanism McKinney has to use to get their urban transportation services. Lengthy discussion followed. To summarize, Commissioner Hill stated he doesn't want to impact the City negatively. The only option the County would take off the table is to remove CCART as a provider.

McKinney Councilwoman Geralyn Kever came forward to address the Court. Councilwoman Kever thanked the Commissioners for focusing on rural transportation. She has met with non-profit organizations and they have expressed the need for transportation. The Councilwoman said what we had in the past is broken and doesn't work. She agreed that there are two issues: a service provider and a transit district. She had questions and wondered if there was a hybrid approach that might be taken. Councilwoman Kever thanked the Commissioners' Court for allowing McKinney to fact find and present options.

Tracy Rath, McKinney, came forward to address the Court. The City of McKinney has discussed a lack of transportation for a long time. Ms. Rath hopes that the City will take the time afforded it to allow the County's work to serve as a catalyst for the decision that has to be made. Ms. Rath spends a lot of time in hospitals and hears how people struggle to get services from CCART.

Jodi LaFreniere Ray was present from the McKinney Chamber of Commerce. Ms. Ray asked that this issue go before the full tax board before the Commissioners' Court makes a decision. The impact on the decision the McKinney City Council has to make is significant. Ms. Ray wants everyone to take time to evaluate the best long-term solution before selecting a provider. She suggested taking the opportunity to interview other providers to make the best decision for our region as a whole.

Jessie Huddleston with North Central Texas Council of Governments was the next speaker. Ms. Huddleston said COG has three interests: planning, coordination and funding and implementing projects. The service provider is less important to COG than the actual coordination of services.

Judge Self suggested that Commissioner Hill hold his motion on this issue in order to give the City of McKinney time to vet. Commissioner Hill agreed. The Commissioner called Eric Gleason forward. Mr. Gleason is the Division Director for Transportation for TxDOT. The Commissioner asked Mr. Gleason about timing for funding for FY2013. Mr. Gleason replied McKinney is not in jeopardy of funds running out; however, there is a clock ticking on how much flexibility they have to make changes.

Extensive discussion followed. Commissioner Williams wanted to hold off on a decision. She is not an advocate of CCART but they provide service for the southeast corner of Collin County. The Commissioner would like to see intent from TAPS to do the same. She suggested bringing in competition and doing an RFP. Commissioners Webb and Shaheen would like to give the City of McKinney an opportunity to come back before the Court as they only learned of this matter a few days before.

Judge Self stated the Court wants to give the City of McKinney time to act; however, the decision still rests with the Commissioners. There will be a rural transit district and a rural transit provider.

Commissioner Hill invited Jay Davidson, Chairman, TAPS Public Transit Board of Directors, to come forward. Chairman Davidson stated he joined the TAPS Board in 2009. He's seen a lot of progress and success. Chairman Davidson was optimistic about TAPS coming to Collin County. The goal of the TAPS Board is reaching out and helping people. They want to see where the need is and meet that need.

Commissioner Hill said he would pull his motion. He looks forward to having this item back on the agenda to meet the needs of those in the community. (Time: 8:37 p.m.)
