Also, Mr. Luscombe would like to see a 500-foot right-of-way adjacent to the Outer Loop developed into a linear park for the public to be able to travel along and visit the six historical sites located there.

Commissioner Hill asked Mr. Luscombe if he was in favor of changing the name back to Foster Crossing Road. Mr. Luscombe replied he was in favor of the change.

#### **GENERAL DISCUSSION**

5. Al-36587 Tax Assessor Collector audit findings, Commissioner Precinct 4.

Bill Bilyeu, County Administrator, stated Mr. Maun was present to address the Court at the request of Commissioner Webb.

Kenneth Maun, Tax Assessor Collector, came forward and admitted he was remiss for not responding to the audit reports that were presented the last two weeks. Corrective actions have been taken in his office to correct the matters brought forth in the audit. Mr. Maun stated he was embroiled in other items in his office rather than paying attention and responding to the audit report received. All of the items on the report have been corrected and most were being corrected during the time the audit was conducted. Mr. Maun apologized for the audit being presented without a correct response.

Jeff May, County Auditor, stated members of his staff have been working in the Tax Assessor Collector's office and they expect to have a favorable audit in response.

Commissioner Williams asked if the bonds are all current. Mr. Maun replied yes, the bonds have been maintained over time. However, due to changes in personnel they were not as current as they could have been.

Judge Self thanked Mr. Maun and asked that he be available should Commissioner Webb have questions for a future court. (Time: 1:42 p.m.)

6. Al-36589 Update on Janitorial Services, Commissioner Precinct 3.

Commissioner Hill asked for an update on the new vendor for janitorial services. Dan James, Facilities, came forward with the update. Facilities maintenance is a 24/7 operation consisting of housekeeping, facilities maintenance and grounds keeping. The contract for housekeeping consists of providing services for over 730,000 square feet. The contract is currently awarded to James Enterprise following an interim period where the County did not have a permanent contract due to changes in the bidding of the contract. Mr. James stated housekeeping is an area that can always be improved and that is what they strive to do.

The guidelines of the contract for housekeeping must meet the requirements of Homeland Security. There are typically 33-34 employees and they work from 5:00 p.m. to 10:00 p.m. cleaning the square footage previously stated. Mr. James explained the policies for maintaining housekeeping procedures. For instance, if an office door is closed, the office will not be cleaned. If an office door is open, the office will be cleaned

and the door shut. Carpets are vacuumed two-three times per week, floors are waxed and stripped twice a year and carpets are shampooed twice a year to avoid damage to the carpet fibers.

There are exceptions. The health care facility has special specifications. It is cleaned nightly from top to bottom. All public restrooms are cleaned daily. Facilities provides all supplies to the vendor and occasionally they run out due to high demand. There are five day porters that take care of the necessities that can't wait until 5:00. Two porters are located in the Bloomdale Courthouse, one in the Administration Building, one in the Sheriff's office and one in Plano. The day porter also takes care of the Auditor's office and District Attorney's office during the day due to sensitive documents. The night crew takes care of areas that are not under lock and key.

Housekeeping is a never ending business. Mr. James stated he receives compliments on the day porters from county employees. He invited the Commissioners to meet with Brenda Turner, his Contract Coordinator. Ms. Turner works after hours from 10:00 a.m. to 7:00 p.m. on Tuesdays and Thursdays.

Commissioner Hill thanked Mr. James for the update. (Time: 1:53 p.m.)
