6. Al-34804 83rd Legislative Agenda for 2013, Commissioners Court.

Judge Self asked Court members to follow item HB 3577 which pertains to the County's permanent seat on COG (Council of Governments). The bill was filed by Representative Pat Fallon out of Denton County. A committee hearing is expected next week.

Mr. Bilyeu noted Court members received a status report tracking each bill and asked if the Court would like to continue to receive such a report. The Court replied yes.

Commissioner Shaheen briefed the Court on his legislative testimony in Austin last week. The Commissioner spoke to the House Technology Committee on government transparency. Representative Fallon has a bill introduced that would require government entities with populations over 50,000 to video stream their meetings and also provide video archives of those meetings. Commissioner Shaheen testified to Collin County's experience and recommended that live video streaming not be made a requirement due to the cost involved and to consider changing the threshold to a number higher than 50,000.
