Fire Marshal Jason Browning came forward with a request for a change to the contract for compensating fire protection in the unincorporated areas of Collin County. Currently the county is contracting with the Fireman's Association. The proposal would have the county contracting directly with the individual departments. The contract would be based on population served and square mileage in a particular fire district. A motion was made to approve the change to the FY2014 contract. (Time: 1:41 p.m.)

Items of note: Jobs Access/Reverse Commute, the Mayor of Mesquite asked that this item be held in order to force DART (Dallas Area Rapid Transit) into conversation with non-member cities about contracting with them for service. It was approved following discussion. Commissioner Williams directed the Court to a power point presentation. Discussion followed with Commissioner Williams explaining the North Central Texas Service Area maps.

The Mobility Plan passed with no discussion. Commissioner Williams anticipates further discussion about the NETEX (Northeast Texas Rural Rail Transportation District) corridor.

Commissioner Williams recommended the Court look at two house bills. HB 2875 is a bill that will allow counties to retain a fee on Air Check Texas which currently is going to the state. It is a fee that is supposed to come back to the counties, but never does.

HB 7 deals with dedicated accounts in general and the legislature not being able to use dedicated accounts to balance their budget. (Time: 1:51 p.m.)
