Earl Holloway has offered to purchase 503 Bumpas St., McKinney, Texas (BEING .17 ACRES OF LAND OUT OF ABSTRACT 1000 IN THE G. A. WILSON SURVEY, AS RECORDED VOL. 959, PAGE 228 OF THE COLLIN COUNTY DEED RECORDS) for \$8,500.00.

This property was sold at a Sheriff's Sale on October 6, 2009 pursuant to delinquent tax collection suit number 199-01583-2008. There were no bidders and the property was struck off to the City for itself and on behalf of the other taxing jurisdictions.

The property's most recent value according to the Appraisal District is \$16,000.00. The property was struck off for the total judgment amount, \$7,408.70, which includes taxes, penalties and interest, costs of court and costs of sale.


Pursuant to the Texas Property Tax Code the court costs and costs of sale must be paid first out of the proceeds of a resale. Those costs total \$2,915.60. Once all amounts due under the judgment have been paid, any amount above that would be distributed to the taxing jurisdictions pro-rata to their amount of taxes in the judgment. A breakdown of amounts each taxing entity will receive is enclosed.

If any taxing jurisdictions agree to accept \$8,500.00 for the property, the property may be sold for that amount. Each jurisdiction must execute the deed.

If your entity decides to accept this offer, enclosed for execution is a Special Warranty Deed our office prepared for this resale. When the Deed is executed, please return it in the enclosed self-addressed, stamped envelope.
