This personnel change involves a current employee stepping down to a lower level position, yet maintaining the pay he currently has. Judge Self is concerned there might be unintended consequences with this move.

Bill Bilyeu, County Administrator, stated that after lengthy discussions with staff, the policy being brought forward to allow this move states that as long as the individual was not moving within their department (this would be considered a demotion), and as long as the individual has held their current position for a year and is considered a good long term employee, they could keep their current pay. In this specific personnel change, the individual's current job, and the job they are wishing to move to, is within the same pay range. If the new job was not in the same pay range as the previous job the individual could not keep the higher pay.

After a lengthy discussion, the concern for any unintended consequences brought about a motion to approve the personnel change but not to approve the policy change brought forward by Mr. Bilyeu. Judge Self stated the Court needed more time to consider the policy. (Time: 2:05 p.m.)

GENERAL DISCUSSION

5. <u>Al-36577</u> Audio Visual for Justice of the Peace (JP) Courtrooms (RFP No. 2013-185), Justice of the Peace, Precinct 1.

Judge Paul Raleeh, Justice of the Peace, Precinct 1, came forward and asked the Court for their approval on expenditures totaling no more than \$200,000 to update the Justice of the Peace (JP) courtrooms. Currently the majority of JP courtrooms are not equipped with sufficient technology, some courtrooms only having a VCR and a chalkboard. There is a need for evidence and other information to be displayed on overheads, projectors, monitors, and a need for microphones, especially on the witness stands.

Commissioner Shaheen felt the request was asking for too much and asked that the request be scaled down only to what is necessary. After a lengthy discussion, Judge Self asked Caren Skipworth, Information Technology, to scope out each of the JP courtrooms and come back with an estimate for upgrades with Commissioner Shaheen's request in mind. Commissioner Williams added it should not be assumed that just because Judge Raleeh's courtroom is in a new building with upgrades, the other JP courtrooms should have the same equipment. The Auditor's Office has transferred the county's IGT (Intergovernmental Transfer) for DY1 (Demonstration Year 1) last week in the amount of \$495,000. The remaining money should be transferred into our account within the next week or so. The first UC (Uncompensated Care) payment in the amount of \$350,000 will be made to Tenet in the next two or three weeks. Mr. Bilyeu feels the requirement for each entity to keep track of their measurements might pose to be a major hurdle. (Time: 2:26 p.m.)
