Judge Self stated if the Court wanted to limit what could be obtained, this needed to go in the court order. Commissioner Webb expressed concerns that the agreements would obligate the county to train staff as well as make the county liable. He is in favor of narrowing the scope as suggested by Judge Self. After a brief discussion, Judge Self held this item for the next court to work on the language. (Time: 1:42 p.m.)

#### **GENERAL DISCUSSION**

**5.** <u>Al-36734</u> Inter-Local Cooperation Agreement for Participation with the City of Richardson for 50% participation in the Tax Increment Financing Zone Number Two and further authorize the County Judge to finalize and execute same, Budget.

Bob Townsend, Mayor Pro Tem, came forward and expressed how important TIRZ (Tax Increment Reinvestment Zone) Number 2 is to the City of Richardson and to Collin County. He then introduced Dan Johnson, City Manager, who presented the Court with a brief presentation highlighting TIRZ Number 2.

The zone request is for a vacant piece of land, roughly 211 acres, which is bordered by Renner Road on the south, George Bush Turnpike on the north, DART Red Line on the west, and Wyndham Road on the east. This is a proposed reimbursement relationship made by the developer and reimbursed over time. There is no bonded debt required of this program and capitalization will occur through private sources.

Mr. Johnson was pleased to announce that State Farm's new corporate campus will be built in TIRZ Number 2, bringing in roughly 7,000 employees (80% from outside DFW). Other projects planned for the zone include retail space, medical offices, limited service hotels, 1,200 multi-family units, and public plazas. The project will be finished in spring of 2015 and will have a positive impact on the job market in Collin County.

TIRZ Number 2 will have an early and fast production with quick returns and multiplier benefits. Accepting the Interlocal Agreement means the county will have a 24 year TIF (Tax Increment Financing) relationship with 50% participation in the project. The agreement acknowledges that county monies must follow county policies and the first payment on behalf of the county will not occur until May 2014. The maximum reimbursement amount for the county is capped at \$36 million. After a brief discussion, a motion was made to accept the Interlocal Agreement. (Time: 2:08 p.m.)

Grace Raulston, Licensed Chemical Dependency Counselor, came forward with an annual update on CCSAP (Collin County's Substance Abuse Program). The mission of CCSAP is to provide alcohol and drug prevention and intervention services to all county residents through assessments, referrals, education, and related services.

Individuals are referred to Ms. Raulston through all Collin County Independent School Districts, Juvenile Probation, CSCD (Community Supervision and Corrections Department), Justices of the Peace 3-2 and 3-1, physicians, attorneys, District and County Courts at Law, and through direct referrals from family.

CCSAP helps our community by monitoring drug trends among certain age groups, referring individuals with substance abuse issues to intervention resources, and by educating school officials, parents, and stakeholders about the risks and effects of drug use as well as which interventions are the most effective.

From FY 2011 to FY 2012, Ms. Raulston conducted 354 adolescent assessments and 658 adult assessments as well as conducted numerous presentations about substance abuse. The total number of documented clients and family members served was 3,782.

The 2012 annual program cost was \$108,722. The potential savings to the county is roughly \$1 million when compared to the cost of housing a juvenile in the Collin County Detention Center. To house a juvenile for one day costs the county \$138 and the average length of stay for a juvenile is 33 days.

Commissioner Shaheen asked if it was possible to track success metrics for individuals who have been assessed by Ms. Raulston. Candy Blair, Healthcare, stated the program has not had much luck reconnecting with individuals who have passed through the program, however, she assured the Court the program would attempt success based tracking this year.

Judge Self asked Ms. Raulston and Ms. Blair to find a way to track the success rate of the program. (Time: 2:41 p.m.)

# 7. Al-36749 North Central Texas Fusion Center presentation, Homeland Security.

Kelley Stone, Homeland Security, came forward with an update on the progress of the North Central Texas Fusion Center (NCTFC). The Executive Advisory Board was established in October 2010 to provide oversight and direction as well as set goals for the fusion center. The Executive Advisory Board is made up of various law enforcement agencies throughout the state as well as stakeholders.

The fusion center is responsible for completing requests for information which are made by law enforcement agencies throughout the region, state, and county. The fulfillment of these requests help support criminal investigations and other matters related to emergency management, critical infrastructure, fire and public health from all levels of government affecting our region and state. 107 requests for information have been completed since October 2012. Since May 19, 2012, the fusion center has responded to 581 TSC (Terrorist Screening Center) requests. As of October 1, 2012, 25 Intelligence Products have been created as well as 67 Situational Awareness Products.

In the 2012 Department of Homeland Security Assessment, the fusion center received a grade of 98.2 out of a grade of 100. The average grade for 78 fusion centers across the country was 88.2. In the 2013 Security Compliance Review, the fusion center received a grade of "excellent."

The NCTFC was recognized by the Terrorist Screening Center for outstanding local contribution to the TSC notification process. (Time: 2:55 p.m.)


