GENERAL DISCUSSION

5. Al-36842 Public Transportation Services TAPS/CCART, Commissioners Court.

Peter Bailey, McKinney, came forward in support of TAPS (Texoma Area Paratransit System) as the transportation provider for the City of McKinney. Mr. Bailey informed the Court that he would be available should there be an opening on the TAPS Advisory Board. Judge Self noted that position has been filled by Commissioner Hill.

Commissioner Hill presented an update on the progress of the transit services to the Court and audience members. Council of Governments (COG) had a meeting last week with the cities in the Dallas-Fort Worth UZA (Urbanized Area) asking for direction and looking for consensus. TAPS was named as the interim provider from July 1, 2013, to September 1, 2013. TAPS would provide service to all cities except Plano during that interim period. Plano will continue to be serviced by Irving Holdings and DART (Dallas Area Rapid Transit). From September 1, 2013, forward, TAPS will provide Phase 2 transit services. TAPS will engage the City of Plano and DART on how they would like to service the riders in the City of Plano. Plano is unique to the region because they have transit service through DART. Commissioner Hill concluded by saying we are going to have consolidated service for the county through TAPS.

Commissioner Williams stated she is cautiously optimistic. She is hopeful that TAPS is going to be able to provide a level of service that is adequate. Judge Self said Collin County has given TAPS a big bite of the apple. The Judge feels that execution is important. Commissioner Shaheen noted any time there is a transition, there will be bumps in the road but he has confidence in TAPS.

Commissioner Hill stated on behalf of the compromise brought forward by COG, they will discuss this at their June 13th RTC (Regional Transportation Council) meeting. Commissioner Webb will represent the County at the meeting. (Time: 6:12 p.m.)

General Discussion Items 6, 7, 8 and 9 were discussed together. Nick Bulaich and Rob Collins from First Southwest came forward with a handout for Court members. The discussion focused on bond sales and bond refinancing. Mr. Bulaich's presentation started with a summary of 2013 Bond Sales. Unlimited tax new money and refunding, which funds the roads, had a new money amount of \$28 million and a refunding component total savings of \$801,803, or 4.55% present value savings. Next is an unlimited tax refunding which was taxable. It produced a total savings of \$1,459,786 and its present value savings is 7.86%. Limited tax new money had an offering of \$2.2 million that funded park and open space. The interest rate is 3.2%. And limited tax refunding, which is taxable, resulted in a savings of \$1,284,880 for a present value savings of 7.52%. There are two tax exempt transactions and two taxable transactions.

An analysis was presented showing what the rates would have to do between now and 2015 in order for the County to realize the same amount of savings from the two taxable transactions. Interest rates would have to go up approximately 1% between now and the beginning of 2015. This would result in the County saving a little over \$3.5 million had they not considered this refinancing or refunding issue.

Collin County has a Triple A bond rating, making it one of only six counties in Texas with that rating.

Mr. Bulaich continued his overview, which included a tax rate impact analysis as of June 3, 2013, and discussion followed.
