GENERAL DISCUSSION

5. <u>AI-36918</u> Establish district court and county court at law judges' compensation for the month of September 2013, County Judge.

Cynthia Jacobson, Human Resources, came forward with the 2013 Judiciary Salary Legislation Update.

Recent legislation, effective September 1, 2013, has increased the state's payment to District Judges for compensation. Because the legislation takes effect in September, the final month of FY 2013, Ms. Jacobson asked the Court for direction on how they wished to handle the compensation change for the one month period.

Currently, District Judges are paid \$125,000 as compensation from the state and a supplement of \$14,693 from the county. The state approved a 12% compensation increase bringing the compensation to \$140,000. The last time the state increased District Judge compensation was in 2005. The state has also placed a cap on how much counties may supplement District Judges' compensation. It has been raised from a maximum of \$15,000 to \$18,000.

Ms. Jacobson stated currently the County Court at Law Judges are paid \$1,000 less than the District Judges. Per statute, a County Court at Law Judge shall be paid a total annual salary set by the Commissioners' Court at an amount that is not less than \$1,000 less than the total annual salary received by a District Judge. Per statute, the judge of a probate court is paid at an amount that is at least equal to the annual salary received by a District Judge. Additionally, the probate judge is paid a mandated supplement.

Ms. Jacobson provided options for the Court to handle the recent compensation change for District Judges, but reminded the Court that this would impact County Court at Law Judges and the Probate Judge. The Court could keep the supplement the same as it is currently, increase the supplement to the maximum of \$18,000, or eliminate the supplement.

Judge Self stated he was pleased the state has stepped up to replace the county supplement. He then provided the option of letting the state pick up the District Judges' salary and holding the \$18,000 supplement to address when the Court addresses Elected Official increases. Commissioner Williams stated she was not inclined to eliminate the supplement for the one month period at the end of FY 2013.

Judge Chris Oldner, 416th District Judge, came forward and requested the Court not to cut the District Judge supplement for September 2013. Moving forward he has no issues with treating District Judges like the rest of the Elected Officials in terms of compensation increases, however, he wishes for the District Judges to keep their supplement through the remainder of FY 2013.

A motion was made to keep the supplement the same for District Judges for the month of September with the understanding that this would increase the County Court at Law Judges and Probate Judge's compensation for the one month period. The total impact for the increase would be \$8,970. (Time: 1:48 p.m.)

6. AI-36885 Alternatives to US 75 presented by Bill Hale, County Judge.

Bill Hale, District Engineer for TxDOT's Dallas District, came forward with the US 75 Corridor Study and alternatives to US 75. The US 75 Corridor Study examines US 75 extending from I-635 to SH 121. The construction on US 75 has not alleviated the congestion issues on the highway. In fact, US 75 has the highest traffic count at George Bush and US 75 in the Dallas/Fort Worth area with an estimated 250,000 cars a day. In the next 20 years it has been projected an estimated 400,000-500,000 cars will be traveling through this area per day. The US 75 Corridor Study seeks to find alternatives to improve traffic congestion. Some examples include arterial roads to divert traffic onto parallel roads, passenger rail lines, increasing the number of lanes, and creating managed/toll lanes.

Commissioner Hill stated he does not feel that creating managed lanes would be the sole solution to traffic congestion. He believes it is a tool that can be used to relieve traffic congestion, but should not be viewed as the only answer. Commissioner Shaheen asked if it was possible to get rid of the HOV (High-Occupancy Vehicle) lanes. Mr. Hale stated the HOV lanes were established with federal dollars so the county would have to work with the federal government if they wished to remove the HOV lanes.

Phil Ullman, HDR Inc., came forward and stated the study area includes I-635 to SH 121 from Coit to Angel Parkway. A do-nothing approach would not address the severe congestion in the region and will ultimately lead to more stop and go/standstill conditions.

A traffic study shows that 16% of US 75 traffic travel to/from north of SH 121 (McKinney) and 17% of US 75 traffic travels to/from south of I-635. If nothing is done to improve the current traffic congestion by 2035, the congestion will increase from an average of 2.5 hours a day to 8-10 hours a day. The majority of traffic is commuter traffic.

Commissioner Webb inquired about how funding would be obtained. Mr. Hale commented there might be transportation bills to help with funding as well as private sector opportunities to create private-public partnerships.

After a brief discussion, Judge Self noted there will be a public hearing on this issue around November or December of 2013. (Time: 2:17 p.m.)

Commissioner Hill presented the Court with the TAPS (Texoma Area Paratransit Service) Quarterly update. TAPS hired Mark Pritchard as General Manager for Collin County and Barbara Reeves as Mobility Manager.

TAPS offered positions to 29 CCART (Collin County Area Regional Transit) employees and is currently looking at hiring more drivers. The Collin County Technical Advisory Committee was created by the TAPS Board and the cities in the county that are not in the DART service area will be serviced by TAPS. Effective July 1, 2013, Collin County will have four board members to serve on the TAPS Board. The 4th board member will rotate between the cities of Wylie, Allen, and Frisco and serve two years. Eric Hogue, Mayor of Wylie, will serve the first term.

TAPS is negotiating their lease on the CCART facility in McKinney and continuing to conduct town hall meetings throughout the county. TAPS has begun taking reservations for July 1, 2013, the first day of the transition from CCART to TAPS, and already has 300 reservations. The airport shuttle service and DART (Dallas Area Rapid Transit) Redline Shuttle will begin July 1, 2013. Collin County has been awarded a Rural JARC (Job Access Reverse Commute) Grant in the amount of \$985,000. Commissioner Shaheen asked for a staffing update for July 1, 2013. (Time: 2:27 p.m.)
