GENERAL DISCUSSION

5. Al-33858 RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb gave an update on the RTC (Regional Transportation Council) meeting. Most notably was the RTC's checking into selling the TDCs (Transportation & Development Credits) for real money since currently there are no federal dollars available for any transportation projects. If there is a market for the TDCs, half would go up for sale.

Another item of interest was the proposed change in the East West Funding Distribution. A recalculation of the numbers would take money out of the East region. Commissioner Webb requested back up on their calculations. The magnitude of a one percentage point change, according to Commissioner Webb, is approximately \$2 million. (Time: 1:57 p.m.)

Bill Bilyeu, County Administrator, presented an update from PIA (Public Information Associates). While CMS (Centers for Medicare & Medicaid Services) set up the plan year, hospitals, specifically Texoma, brought up the issue that they operate their budget on a true calendar year. For that reason, the hospitals will have to book a loss this year since they won't be reimbursed until the end of the next demonstration year. This is upsetting to the president and CFO since the outcome of their hospital is based on how they did overall with their net profits. They are expending the money and won't be reimbursed until next year. PIA is checking with CMS and the state to see what changes can be made to book some revenues for this year. With no options available, they will have to wait 16 to 18 months before they receive a payment. (Time: 1:59 p.m.)
