GENERAL DISCUSSION

5. Al-37120 2013 TCDRS Benefits Presentation, Human Resources.

Cynthia Jacobson, Human Resources, came forward to explain TCDRS (Texas County & District Retirement System). The program has a 7% deposit rate, a 200% match, a vesting period of eight years and a guaranteed interest rate of 7%. On the county and city comparisons, the CPI varies by entity.

Due to other expenses incurred with TCDRS, the plan must earn 8% in order to return the guaranteed 7% to the employees. Actuarial gains and losses are smoothed over ten years. When smoothing the gains, there is no set plan design that determines whether the gain is moved to the reserve account or is smoothed to the plan. Reserves can be used to buffer the losses.

Since 2009 the county has been making payments toward the unfunded liability which has brought the rate down from 11.2% to 8.06%. If these payments had not been made, the rate would be going up dramatically in order to pay for the smoothed losses.

The unfunded liability as of 12/31/12 is \$2,794,000 with a 99% funded rate. TCDRS had positive returns in 2012 and TCDRS passed through those gains. The 2012 gains will be recognized over time. The funded percentage has increased significantly since making the lump sum payments.

There are three options with COLA's (Cost of Living Adjustment): flat rate COLA's, CPI based COLA's and doing nothing. The county did flat rates for years which gave every employee the same percent. Last year a 60% CPI increase was approved for plan year 2013. The 60% was applied to a CPI of 1.74%. COLA's are funded over a 15-year period. Currently there are 526 individuals collecting TCDRS benefits, 312 current employees are eligible to retire now and 268 additional employees will be eligible to retire in the next five years.

GASB (General Accounting Standards Boards) looks at how financials are done for public sector entities. GASB Statements 67 and 68 are new this year. GASB Statement 67 impacts TCDRS only while GASB Statement 68 impacts the county. For the first time, beginning in 2015, Collin County will have to report the TCDRS unsmoothed outstanding pension liability on the financials. COLA's will have to be counted for the entire cost of the plan year. Commissioner Williams pointed out that this will discourage COLA's. Because of GASB 68, this will be the first year Human Resources will not recommend a COLA. During budget, the Court will have to determine whether or not to make a payment of the unfunded liability.

Commissioner Williams asked Jeff May, Auditor, whether the unsmoothed unfunded liability would have an impact on bond rating and issuance of bonds. Mr. May does not anticipate it will have a big impact on bond rating because the county is so well funded. It will, however, reduce our net assets when bond buyers are looking at it. (Time: 2:07 p.m.)

Stacey Kemp, County Clerk, came forward to update the Court on the position of Collections Clerk for the Justice Court which is being held in contingency. SB 1863, passed in 2005, required Collin County to create and implement a program to improve in-house collections of court costs, fines and fees. Since implementing the program, payment terms have been reduced significantly and the program achieved a 91% collection rate; an increase of 30% over the prior year.

The Court Collections Program was transferred to the Office of the County Clerk effective October 2010. This program benefits defendants because of its convenience to the County Courts and County Court at Law Clerks and because payment plans are created based on income. By offering these payment plans, previously outstanding costs, fines and fees are being recovered. During the FY2013 budget cycle, two (2) regular full-time positions, one to be filled immediately and the other held in contingency pending the outcome of the program, were approved for the collection of outstanding court costs in the Justice Courts.

This was the first time in Collin County a collection program has been implemented for the Justice Courts. Before this program began, outstanding costs, fines and fees were turned over to a third party collection agency after 60 days at a cost of 30% of the balance collected.

The first court to participate was Justice Court 1 effective October 2, 2012. On November 26, 2012 the newly created position was filled and dedicated to collections for JP-1. The initial caseload consisted of more than 6,700 cases totaling \$1.8 million. In the seven months since this position was filled, \$311,000 in cash has been collected versus \$183,267 collected by the third party agency for the same time period. When deducting costs associated with the collections, the third party agency returned \$128,287 to the general fund while the Collections Clerk returned \$285,334 to the general fund.

With the addition of Justice Court 3-1 by the end of 2013, an additional 2,100 cases representing \$869,000 will be added to the current workload. Due to the increased workload and the success of this program, at this time Ms. Kemp is requesting approval by the Commissioners' Court to fill the position currently being held in contingency to aide in collections for the Justice Courts.

Commissioner Shaheen requested open dialogue during budget to hear from the Justice Courts that are not interested in participating in the program. After a discussion, a motion was made to approve the amendment based on one month in the amount of \$17,095. (Time: 2:19 p.m.)

The last item of interest was the plan to increase some speed limits throughout the MPO (Metropolitan Planning Organization). Only one affects Collin County, and that would be north of Melissa on US 75. The speed limit would be increased from 60 to 70 mph. The reason the speed limits were repressed in these counties was due to the fear of the effect of emissions. There was a presentation showing there is no increase in emissions at the higher speeds with newer cars. All the emissions generated by cars are from idling up to 15 to 20 miles per hour. (Time: 2:24 p.m.)
