Judge Self led the Invocation.

1. Judge Self called to order the meeting of the **Collin County Commissioners' Court** at 1:32 p.m. and adjourned the meeting at 2:27 p.m.

President Self called to order the meeting of the <u>Collin County Health Care</u> <u>Foundation</u> at 2:27 p.m. and adjourned the meeting at 2:27 p.m.

2. Public Comments.

David Quick, Prosper, came forward to express his concern regarding County Road 51 and particularly the Interlocal Agreement. He has been talking to Huitt-Zollars representing RPG (Republic Property Group) regarding construction and drainage easements related to the road construction. Last week a sign went up at the south end of CR51 as it intersects Frontier Park indicating the road was closed to through traffic. Mr. Quick learned this was to close off the north end of CR 51 as it enters the MUD (Municipal Utility District) to restrict access so a subdivision could be built where the road now exists. Mr. Quick sent emails to Commissioner Shaheen, Jon Kleinheksel and Bill Bilyeu expressing concern. The sign was removed the next day and a new road closure sign was posted on CR 51 a half mile from the proposed construction site. Huitt-Zollars told Mr. Quick that MUD will not begin construction of the concrete road for at least a year and possibly never. Mr. Quick feels the road closure is an attempt to devalue his property and make it difficult to market. (Time: 1:39 p.m.)

Roy Serpa, Fairview, came forward to comment on the budget and express the importance of properly funding pension plans for county employees. He stated there are trillions of dollars of unfunded pensions for government employees at all levels. Also, he wanted to inform county employees they cannot expect to have competitive salaries and a benefit plan at 37%. When compensation is reviewed, it must include salary and the benefits package. (Time: 1:42 p.m.)

3. Presentation/Recognition:

a. Al-37228 Recognition of Veteran Services Officer, County Judge.

Judge Self introduced Zachariah Migura. Sergeant Migura is one of the County's Veteran Services Officers and will be deploying to Afghanistan next month. He is a Staff Sergeant in the U.S. Army Reserves, Squad Leader and Assistant Platoon Sergeant. This will be Sergeant Migura's first time to Afghanistan. Judge Self commended his job performance, thanked him for his service and told him his job will be here when he returns. (Time: 1:35 p.m.)

4. Consent agenda to approve: Judge Self deleted item 4c1 and pulled item 4c2 for discussion. He then asked for comments on the remainder of the consent agenda. Commissioner Shaheen pulled item 4b2, and Commissioner Webb pulled items 4b1, 4c3 a-g and 4d3. Hearing no other comments, a motion was made to approve the remainder of the consent agenda. Commissioner Webb pulled this item because the proposal from CliftonLarsonAllen LLP at \$68,500 was significantly higher than two other bids which came in at \$30,500 and \$29,884. The price differential was so large he wondered if there was a mistake. Sara Hoglund, Purchasing, and Caren Skipworth, CIO, came forward to explain there were four proposals received and evaluated. The proposals were reviewed to make sure the scope of services was the same and then narrowed down to two proposals. After speaking with both vendors, getting vendor references and determining which vendor provided the right resources to audit the environment, CliftonLarsonAllen LLP was selected. This is the first time using this vendor. There being no further discussion, a motion was made to approve the item. (Time: 1:46 p.m.)

Commissioner Shaheen felt the direction of the court was to revisit the configuration. Caren Skipworth, CIO, stated this configuration is the single computer in each courtroom, it is centralized, connected to a projector and can be displayed on a screen. The proposal is to reuse the analog microphone and speakers pulled out of the 380 building. The cost then would be for installation only. Commissioner Shaheen questioned why the cost was still \$250,000. Sara Hoglund, Purchasing, explained that amount was originally what was requested but the new cost is actually \$41,449. Monika Arris, Budget, explained this would come out of the JP Court Technology Fund. Judge Paul Raleeh, JP Precinct 1, also came forward to explain the \$250,000 was his error. It should have been put back on the agenda at \$41,449. After a brief discussion, Commission Shaheen moved to hold the item until he could get a better understanding of the District Courts versus the JP Courts. Commissioner Hill agreed to hold the item for a week in order to clean up the verbiage. (Time: 1:54 p.m.)

This would also need to be discussed with the cities to see if they would want to do it. A motion was made to approve the Interlocal Agreement. (Time: 1:56 p.m.)

GENERAL DISCUSSION

5. <u>AI-37209</u> Creation of an Economic Development District in North Texas, County Judge.

Lucille Johnson, NCTCOG (North Central Texas Council of Governments) came forward to give a briefing on forming an EDD (Economic Development District) in North Central Texas. The Regional Office of the Economic Development Administration (EDA) asked NCTCOG to consider forming an EDD representing the North Central Texas region. Our region is the only area within the five-state area (Arkansas, Louisiana, New Mexico, Oklahoma and Texas) covered by EDA that has not yet formed a district. EDA exists to look at ways to create better economic development by helping distressed areas. There are four counties in the North Central Texas region that, due to economic disaster or economic downturn, qualify for forming an EDD. Only one is needed to qualify. The counties are Erath, Hunt, Palo Pinto and Navarro. In order to receive funding, there must be a CEDS (Comprehensive Economic Development Strategy).

Commissioner Hill asked if we had our own CEDS in Collin County, what additional benefit would be available to us by forming an EDD. Ms. Johnson said there would be no additional benefits. Each county could have its own CEDS and does not need to belong to an EDD. The CEDS would need to be approved before any funding would be possible.

After a brief discussion, the Court decided there was no advantage in forming an EDD and no disadvantage in not forming an EDD. Ms. Johnson requested the survey forms be completed and returned so she could inform the EDA. (Time: 2:20 p.m.)
