#### **GENERAL DISCUSSION**

5. AI-37243 TxDOT Annual Update, TxDOT.

Barry Heard, TxDOT Area Engineer, came forward to present the TxDOT (Texas Department of Transportation) update on Mobility Projects. Some of the recently completed projects are along US 380 and include the SH 289 project, Custer Road to Lake Forest and Lake Forest to Bogart, US 75 at Wilmeth Road, the interchange at US 380, FM 982 south of US 380 and the US 380 projects from the lake all the way to the county line with the exclusion of the railroad.

Mobility projects currently under construction include the railroad and Main Street overpasses in Farmersville, ongoing projects along US 75 in McKinney, the McKinney project from White Street down to SH 121, Telephone Road south to Bloomdale Road, the interchange project in Melissa, FM 455 in Anna, SH 289 in Prosper, FM 1461 to FM 455, the FM 3537 Main Street project in Frisco, FM 2551 from Parker to Murphy, and two projects that Mr. Heard's office is not monitoring on SH 78 in Lavon and Wylie.

Some of the upcoming mobility projects include US 75 in Allen which is a \$60 million project to add a seventh and eighth lane; FM 2786 in Fairview and FM 2514 in Parker are both being converted into a six-lane divided urban section. A consultant is beginning preliminary engineering on the interchanges at SH 121 and FM 455, FM 2862 and SH 160. The US 75 and FM 455 interchange project in Anna is currently unfunded but they are beginning the design process. Judge Self asked when they will relieve the intersection of US 75 and FM 455 with a stop sign or a light. Mr. Heard will look into it. Finally, the US 380 project from County Line to Custer Road is split into two projects: the interchange projects at DNT (Dallas North Tollway), SH 289 and the railroad overpass, and urban rewidening east of SH 289 to Custer Road.

Mr. Heard then discussed the FM 2514 projects. Sixty percent of the plans for these projects from FM 2151 to just east of Lavon Parkway are funded. The TPD (Transportation, Planning and Development) director informed Mr. Heard that a consultant will begin schematic development for the remaining 2.4 miles of that section of road. There is an overlay project that will start in the next two weeks which will include either milled rumble strips or raised profile markings up to FM 2551 to improve safety. Commissioner Williams expressed the Court's appreciation for TxDOT's efforts since there have been at least two fatalities and a number of other accidents on this roadway in the last six months.

Contracted maintenance for FY 2013 was \$4.2 million on routine maintenance contracts for striping, guard fence/median barrier repair, pavement repair, crack seal, bridge repair, seal coat, tree trimming, culvert repair, removal of debris, HOV maintenance and various overlays. Mr. Heard showed pictures of some of the completed projects.

Rehabilitation projects underway or completed include FM 6 and FM 1777 which were most problematic. The culverts have been improved and the shoulders widened. FM 547 will also have culvert and shoulder work done next year. FM 2755 rehabilitation was done with in-house forces. SH 5 from Wilson Creek south of FM 1378 will have an overlay project starting. Another overlay project north on SH 5 will start within the next 30 days. FM 543 widening with three-foot shoulders will continue to US 75.

One project Mr. Heard is particularly happy with is the mill and inlay on US 75 from Melissa Road to the county line. Due to the number of accidents, six miles of that roadway were resurfaced and the profile was adjusted. FM 428 southwest of Celina from the county line to FM 455 is being widened in 2015. Judge Self asked about the unpaved triangle at the county line on FM 428. Mr. Heard said their project does not include the unpaved triangle. Our project will tie into Denton County's project at the county line. Mr. Heard will check to see if Denton's TxDOT plan includes paving that area.

Mr. Heard provided the website, <a href="www.keepitmovingdallas.com">www.keepitmovingdallas.com</a>, which shows all of the upcoming mobility projects and Public Hearing documentation. Commissioner Shaheen asked how much money from TxDOT's budget is being spent in Collin County. Since Collin County is one of the faster growing counties in the nation, the Commissioner would also like a comparison as to what is being spent on other counties. Currently, RTR (Regional Toll Revenues) money is funding the Collin County projects. The US 380 project west from the county line to FM 289 had to be supplemented with federal funds, and the FM 455 project in Anna will have to be fully funded with federal funds.

Currently, all of the RTR is programmed and underway, and we will have to get back to traditional funding. Judge Self stated, when the region accepted the RTR dollars, they said the county would not suffer the normal funding because we accepted RTR dollars. Mr. Heard does not feel Collin County has suffered from accepting RTR dollars.

Commissioner Webb asked that the comparison Commissioner Shaheen is asking for not reflect the RTR dollars. Mr. Heard will provide that information and went on to explain some counties in west Texas have really suffered over the past few years with their funding. Recently, with the boom in oil and gas, these counties were able to supplement some of their budgets with service taxes. (Time: 2:00 p.m.)

Andrea Stroh Thompson, District Clerk, came forward and first wanted to commend some of the other offices. The Office of the Attorney General Child Support Division performed a review of the Collin County Court Costs. They reviewed the services provided which Ms. Thompson's office performs in conjunction with the Attorney General's child support cases. Another part of the audit involved the transactions with the Constables for Precincts 1, 3 and 4 and the Sheriff's office. The review found there were no errors with any of the process serving with the Constables' and Sheriff's offices. The District Clerk's office had less than a 1% error rate for the thousands of transactions done for the Attorney General. Ms. Thompson was proud of her office and wanted to commend the Constables and Sheriff and thank them for their cooperation with the review.

Ms. Thompson presented a synopsis of the Preservation and Restoration Records and Archive Plan for her office for FY 2014. The goal is to continue with the preservation of anything that is on permanent retention and preserve anything that predates 1950. They are doing more books to identify any that predate 1950, and will move into more permanent preservation of those documents that won't need to be in the disaster proof bindings. The records will be stored in acid-free folders so they don't deteriorate. A portion of the files are not digitized, therefore, are not publicly available. We will identify which of those records need to be made electronic so they can be available to the public.

Judge Self asked if acid-free folders will be enough for the oldest records or will restoration be needed. Ms. Thompson needs to first determine if the funding is available and explained these funds are collected from court fees specifically for the preservation fund. The goal is to have all records that predate 1950 put into the books. This process is expensive and time consuming. The first priority is to slow down the deterioration before putting them into the books. We as a county are very lucky to have climate controlled storage.

Judge Self opened the Public Hearing at 2:05 p.m. and asked for comments. Hearing none, the Judge closed the public hearing at 2:05 p.m. A motion was made to approve the plan. (Time: 2:06 p.m.)

Tony Ruggeri, Republic Property Group, came forward to present the Light Farms update. The Light Farms project is in the ETJ (Extraterritorial Jurisdiction) of Celina in the Prosper School District and this year it was awarded the Dallas Business Journal's "Best Single Family Real Estate Deal of the Year." There have been 45 homes sold to date with only one model open. Four more models will open in October and by next February there should be six models. There is a road in the project, CR51, and those plans are currently out for bid. They are working with the City of Celina to finalize their approval of the plans. Once approved, the construction should take 150 days so the road should be paved by spring of next year. The average home prices are \$360,000 and that price point is expected to grow. Commissioner Williams said Light Farms is a beautiful development and they have done a stellar job. (Time: 2:07 p.m.)

Bill Bilyeu, County Administrator, explained the federal government is reviewing participation in some of its programs and is looking for counties or entities qualified for programs but have opted not to participate. The CDBG (Community Development Block Grant) is one that has come up for the Court's review. CDBG is completely focused on low income areas providing housing opportunities, propping up housing values and back-stopping mortgages. This program is completely separate from the Collin County Finance Corporation, but it is exactly what one would see in the Housing Authorities in cities. If Collin County participated in CDBG, it would only cover areas where the County has jurisdiction but does not have a Housing Authority. This would pertain to all the small towns, cities and unincorporated areas. The reporting requirements for CDBG are onerous. All urban counties in Texas participate in this program.

Mr. Bilyeu's recommendation to the Court is to not participate because the staffing and bureaucracy involved would cost as much as the County would be able to put out in grants. Commissioner Williams said both she and Commissioner Shaheen served on similar boards and can attest to the magnitude of red tape involved and would not want to take on the administrative hassle. No motion was made to participate in the program. (Time: 2:13 p.m.)
