Judge Self pulled this item for a discussion of a flat rate for meals. Jeff May, County Auditor, did a study using three months of travel for FY 2013. The study compared the proposed travel policy of using a per diem for meals vs. collecting receipts. The study was based on a per diem rate of 80% of the rate established by the Governmental Services Administration (GSA). Collin County typically came in 30% less than the GSA. The per diem would include meals and incidentals such as tips throughout the day. The first and last day of travel would be reimbursed at 75% of the GSA and there would be no reimbursement for travel departures after 7:00 p.m.

Judge Self would like to move to a per diem rate; it would reimburse employees with less work. The Judge recommended 80% of the rate established by the GSA as recommended by the Auditor. A brief discussion followed.

Commissioner Shaheen made a motion to approve the adoption of the Collin County Travel Policy with language added that per diem reimbursements would not be available for departures after 7:00 p.m. or for conferences where meals are provided. (Time: 1:47 p.m.)

Judge Self asked Jeff Durham, Parks and Projects Manager, for an overview of how our open space bond funding is going rather than just the \$2.2 million requested in the agenda item. Mr. Durham presented a slide entitled "2007 Open Space Bond Program, \$17 Million Approved by Citizens". Mr. Durham looked at all the bond series going back to 1999, but started with the 2007 program since today's projects were being funded from that bond sale. There have been four series in the 2007 program. The first was in 2009, then 2011, 2012, and 2013. The total allocated for the four years was \$10.2 million. Last year Commissioner Webb had \$1 million set aside for future use at Myers Park. That leaves a balance in the 2007 program of \$6.8 million. There are also balances in the 1999 and 2003 sales. The 1999 balance was just slightly less than \$16,000; the 2003 balance was \$318,000. The 2007 balance was \$1.4 million, with \$1 million being set aside for Myers Park as requested by Commissioner Webb. The total excess from the 1999, 2003 and 2007 bond sales is \$746,000.

Judge Self's question had to do with the request for \$2.2 million. They are looking to fund a little more than that with the balance coming from the 1999 or 2003. Discussion followed of distribution of funds among cities in Collin County.

A question was raised as to sidewalk requirements in smaller cities such as Blue Ridge. Mr. Durham stated his office does not have sidewalk requirements, but they make smaller cities aware that they will have to meet requirements as specified by the Americans with Disabilities Act (ADA).

GENERAL DISCUSSION

5. <u>AI-37392</u> FY2014 Employee Reclassifications, Human Resources.

Cynthia Jacobson, Human Resources, came forward to request approval for FY 2014 employee reclassifications. A reclassification can be requested for various reasons such as an individual department indicates a concern about a specific job that they want analyzed specifically to look at the compensation level for that specific job; a new department head or elected official may want to rearrange the department to meet their needs; or there could be a situation where there has been a change in job responsibilities where there would need to be a movement of salary. Ms. Jacobson presented the Court with the FY 2014 employee reclassifications as recommended by Human Resources.

Sheriff Terry Box asked if he could come forward to address the Court. The Sheriff's office asked HR to look at the salaries for transfer officers. Five years ago his transfer officers were adjusted to a position between a bailiff and a detention officer. For the month of May his 26 transfer officers served as bailiffs 101 times, made 41 arrests at the request of the Courts, made 11 arrests in the Courthouse parking lot and stayed over 27 times for Court purposes that went beyond regular County hours. The Sheriff was asking that the transfer officers be brought up to the salary level of the bailiffs. Following discussion, the Court questioned why the transfer officers should be paid the salary of a bailiff if they are only performing the duties one-fifth of the time. Judge Self recommended not changing the transfer officers' salaries. The transfer officers can aspire to move to the next level.

Cynthia Jacobson, Human Resources, returned with a Salary Analysis as discussed in Budget Workshop. The salary analysis has adjustments recommended by Court where HR eliminated entry level position amounts under 2%. As a result of a questionnaire sent to department heads and elected officials asking why these positions would be hard to replace, HR looked at their performance, adjusted a couple to take performance evaluations into account and reduced the amounts accordingly. This is a one-time situation. HR will not come to the Court each year with this request. The analysis is to look at years of experience in a job, and what salary would be reflective of that experience. The request is for \$300,000. In the last couple of years, due to budgetary constraints, salaries have not moved along the market range. Ms. Jacobson explained the various factors reflected in the study.

Lengthy discussion followed. Commissioner Hill expressed a level of unease with the analysis. Commissioner Shaheen is concerned about individuals on the list whose requests were reduced due to performance; the Commissioner felt that was contrary to the study. Ms. Jacobson said the amount the employees' salaries are off is not all due to performance. A concern was whether it will cost more money to replace these individuals if they leave. The cost could be a higher salary for a certain skill set or the cost could be related to training, errors and a learning curve.

8. AI-37470 LIRAP Update, County Judge.

Chris Klaus, Senior Program Manager, North Central Texas Council of Governments (NCTCOG) Transportation Department, had a Power Point presentation entitled "Air Quality Initiatives: Funding Update" which updated air quality funding initiatives for the Low Income Repair and Replacement Assistance Program (LIRAP), the Local Initiatives Program (LIP) and the Texas Emissions Reductions Plan (TERP).

The purpose of these programs is a regional effort of trying to reach attainment for the pollutant ozone. There are nine counties in the DFW nonattainment area. The EPA (Environmental Protection Agency) reviews the standards every five years and due to changes makes it more difficult for regions to show compliance.

LIRAP helps low to middle income residents repair or replace vehicles that fail inspection or are greater than ten years old. They are funded by inspection fees of \$6 per vehicle collected and distributed by TCEQ (Texas Commission on Environmental Quality). If a vehicle fails inspection, the owner is eligible for a voucher good for up to \$600 in repairs and up to \$3,500 for replacement. Repair assistance is offered year round; replacement assistance is offered for a limited time during the year due to reduced program funding. Fees continue to be collected but the Texas Legislative Budget did not appropriate the program funds to North Texas Counties. 12.5% has been funded for the entire state.

Commissioner Shaheen referred to Article 6, Section 6.1, "...participating counties". The Commissioner asked, what is a non-participating county? Mr. Klaus explained it's a two-part process. A county has the ability to participate if that county has an inspection program. All counties have a safety inspection, but Wise County, for example, does not have an emissions inspection. A county has the option to participate in the repair-replacement program.

Judge Self stated if a county does not participate in the program, they still must collect the \$6 fee per vehicle. The \$6 would not be sent to a regional pool. The county would have to use the funds or send the money to the state. Our citizens have to pay the \$6 for the mandatory emissions test; it's what happens to the \$6 that is in question. The Judge stated it is a very passive program which is why so little of the funds are spent in Collin County.

Continuing, Mr. Klaus informed the Court that for Fiscal Years 2003-2013 \$23 million was collected by Collin County residents and \$1.09 million was allocated to local initiative projects. Although \$23 million was collected, only \$13.5 million has been appropriated back out to the county since the program was started. In the last few years funds coming back to the county have been reduced. The remaining money, \$10.1 million, is being used in the Clean Air Account to balance the general budget. Discussion followed of a \$2.9 million carryover amount contributed to Regional Pool 2. Judge Self asked Mr. Klaus to return with clarification on that.

For FY 2014 the legislature has funding allocated to Collin County of \$342,517. To clarify the imbalance, Judge Self stated Collin County will collect \$6 for every vehicle inspected but only get \$342,517 returned per legislature.

COG is working to return funding to the region. Targeted outreach for LIRAP include:

- Focus on inspection stations in high failure rate zip codes
- Hosting seasonal car care clinics with local repair facilities
- Dealerships (once replacement assistance is open)
- Public meetings

The presentation moved to a discussion of LIP. Funds are collected out of the \$6 collected for vehicle inspections. Use of funds include:

- Expand/exhance LIRAP
- Develop and/or implement remote sensing and smoking vehicle programs
- Coordinated efforts with Regional Emissions Enforcement Programs and Emissions Task Forces
- Transportation System Improvement Programs
- Other control strategies to assist in complying with National Ambient Air Quality Standards

LIP has collected \$1.09 million for FY 2008-2013. \$1.01 million has been expended. For FY 2012-2013 \$78,000 maybe be transferred to Dallas County to allow them to continue their enforcement program.

TERP was established in 2001 and helps with heavy duty diesel vehicles and locomotives. Funds come from vehicle certificate of title/title transfer fees. For FY 2002-2012 \$1.6 billion has been collected throughout the state. In the DFW region over \$300 million has been spent through FY 2012 on projects involving 5,690 activities.

Mr. Klaus stated he will return to the Court with reports and updates. COG is committed to address the issue that there is less money coming back to residents. Judge Self wants a report on the discrepancy of funds collected versus funds returned to the County. (Time: 2:35 p.m.)
