Against: 6,839



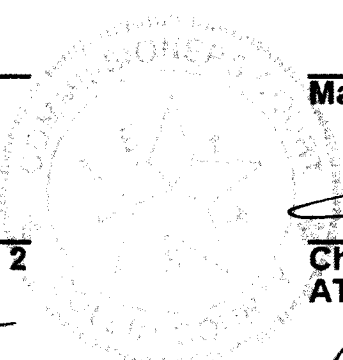


Proposition 9: For: 32,056
