GENERAL DISCUSSION

5. **AI-37751** Designation of staff contact with TCDRS, County Judge.

Judge Self stated since pension plan discussions were concluded, he thought the County should have a single point of contact with TCDRS (Texas County and District Retirement System) for the future. The Judge made a motion to designate Collin County's Human Resources Department to be the staff point of contact for TCDRS.

6. **AI-37700** Health Care Reform requirements relating to out of pocket maximum, Human Resources.

Cynthia Jacobson, Human Resources, came forward with an update to a previous discussion on Health Care Reform requirements.

The items under discussion were changes per the Affordable Care Act (ACA) relating to out-of-pocket maximums. Deductibles, co-pays and co-insurance would now have to be included towards out-of-pocket maximums. Previously Collin County's plans did not apply these payments to the out-of-pocket maximum and they would remain the

employee's responsibility regardless of the total claim costs. The request is to make changes to Collin County's health plan in accordance with the Health Care Reform by applying co-payments and deductibles to the out-of-pocket maximum and maintaining current costs by raising out-of-pocket maximums. If a change is not made, the County will absorb the additional costs.

With approximately 3,000 individuals insured, that is potentially \$1,000 of additional expense per insured that has been actuarially calculated on average for a total of \$3 million, not \$300,000 as stated in a previous Court. That is the maximum expense that could be anticipated if every insured went to the maximum. Following a discussion with United Health Care, Ms. Jacobson learned the calculation for an anticipated amount is probably closer to \$700,000.

The County's cost for employee health is approximately \$16 million per year. Judge Self felt spending \$700,000 is equivalent to another wellness program. Commissioner Williams thought it should be looked at on an annual basis. Ms. Jacobson said she will not have enough data until the plan has been in place for a full year. Following brief discussion, Judge Self recommended the Court wait because of the disincentive to wellness. (Time: 1:44 p.m.)
