Commissioner Webb pulled this item to gain clarification as to where the funds for the County participation of \$40,970.40 are coming from and to address the lack of language stating the County's monetary responsibility in the funding agreement.

Tracy Homfeld, Engineering, explained that the funding will be reallocated from the City of Murphy's Betsy Lane bond fund. The Betsy Lane project received RTR (Regional Toll Revenues) dollars; therefore, the allocation of bond funds from the County will be reduced and reallocated to the FM 2551 project as the County's participation. An MOU (Memorandum of Understanding) or an interlocal agreement will be brought back to the Court explaining the reallocation of funds for the use as the County's participation in the FM 2551 project. This will also state that if there are any overages in the project that the funds will again be reallocated from the Betsy Lane project.

Commissioner Hill asked for the balance of the Betsy Lane bond fund and if there are sufficient funds to pull for reallocation. Ms. Homfeld stated, yes, there are several hundred thousand dollars in the bond fund.

Commissioner Webb commented that with a written agreement stating that funding for FM 2551 is being reallocated from the Betsy Lane project and that any overages will also be pulled from said project he would move to approve the item. (Time: 1:38 p.m.)

Commissioner Webb pulled this item to question the impact on the County's use of easement at this location with future road improvements. If this does impact the County's easement, the Commissioner is hesitant to approve the item.

Jeff Durham, Special Projects, addressed the concern. The answer is no, it will not impact the ability to use the right-of-way for the purpose intended. There is a clause in the agreement for a nonexclusive easement allowing other utilities in the area as long as they do not interfere with the waterline. In the future when the new lanes of Stacy Road are ready to be built, North Texas Municipal Water District (NTMWD) will pay for the relocation of the waterline if there is no way for the County or NTMWD to work around them.

Judge Self asked why it is not assumed the road will be built there to ensure the waterline is not underneath the road. Mr. Durham said the only other option would be putting the waterline in the median of the six-lane divided road that has 120 feet right-of-way. Commissioner Williams stated that this is a crucial pipeline for the community. Mr. Durham agreed and said that other routes were looked at but the proposed plan was determined to be the best alignment. Commissioner Webb was comfortable moving forward with the item due to NTMWD taking responsibility for the relocation of the waterline if necessary in the future and made a motion to approve the item. ## **GENERAL DISCUSSION**

**5.** <u>Al-37522</u> Purchase wearable video cameras for the Constable Deputies utilizing CIJS funds in the amount of \$41,314, Information Technology.

Lonnie Simmons, Chief Deputy, Constable Precinct 3, came forward to discuss the item. The intended use of the wearable video cameras by the deputies is to record daily activities in the civil aspect of law enforcement. There were two occasions this year where officers were assaulted while executing writs of attachment for children. These incidents then turned into criminal cases and the use of wearable video cameras would have provided video documentation of those events. The use of wearable cameras during court ordered property seizure will be to video document the seized property for inventory, the condition of the property and the conduct of the defendants and the deputies involved. Another use is during Sheriff Sales; if there is a dispute on the sale of an item, the deputy can take off the camera and replay the video for proof of the sale.

The purchase of the cameras includes a one-year out of the box warranty and a two-year extended warranty. The vendor will upgrade the cameras, at no charge, during the warranty period if an upgrade was performed.

A policy is in place for the use of the cameras and is available for review. The procedure for video storage is if the video recorded is not for use in a criminal case, it will not be kept longer than 90 days. The video will be downloaded from the cameras and saved to a flash drive or CD (Compact Disc) as not to use County server space. The flash drive or CD will then be stored in the locked evidence room. Only one officer has a key to the evidence room so the video will be secure. It is very important to protect public interest and Chief Deputy Simmons believes we have a great product that is durable and will have a long life.

Judge Self asked if the cameras are hardened or militarized. Chief Deputy Simmons was unsure if the cameras are militarized but said they do have hard cases. The cameras also have a flap that covers the lens when not in use.

There was a brief discussion on how the video is downloaded from the cameras to the police car and to the office computers in order to save on flash drives or CDs. Funding for the purchase of the flash drives and CDs will come from the office supply fund. The discussion reiterated the video footage will be kept no longer than 90 days unless it is considered evidence in a criminal case. If the footage is used as evidence, it will be uploaded to the Odyssey system under the case file. All footage that is not used as evidence will be purged after the 90-day period. During the 90-day period all footage will be stored in the secure evidence room.

Commissioner Reid asked if there is any history on how often the vendor upgrades the cameras. Caren Skipworth, Information Technology, said she does not have that information but did note the wearable cameras will have more wear and body damage than the ones mounted in the vehicles. The Commissioner commented on the line item of the two-year extended warranty and noted the cost of the extended warranty is as much as it would be to replace damaged cameras and questioned the necessity. Judge Self agreed with the Commissioner and asked since the purchase is for a more durable camera, is there a need for the extended warranty. Ms. Skipworth stated that if the extended warranty is not purchased, a funding mechanism will need to be set up for repair or replacement of the cameras. Judge Self asked Ms. Skipworth to provide documentation on a different way to procure the cameras other than an extended warranty. Commissioner Hill asked if this line item could be set up as a contingency fund to self-insure the cameras. Ms. Skipworth confirmed that can be done. Judge Self recommended the approval of this item minus the two-year extended warranty

Monika Arris, Budget, came forward to remind the Court the cameras are being purchased with the short-term debt funds that go along with the court management system. The repair and replacement of cameras will then fall under the general fund if the extended warranty is not purchased.

Commissioner Williams made a motion to accept the purchase of the cameras with the exception of the extended warranty. The Commissioner asked Ms. Skipworth to bring back to the Court an assessment of the best option, to either purchase the warranty or put the warranty money into a contingency fund. (Time: 1:55 p.m.)

## 7. Al-33858 RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb presented the RTC (Regional Transportation Council) monthly update. There were two meetings in the month of December. One was a special meeting held on December 5, 2013. The most noteworthy item was the approval of the State Highway 360 partnership. This was where Texas Department of Transportation (TxDOT) offered a \$300 million loan to accelerate the toll construction of Highway 360 South at the Green Oaks intersection. TxDOT made the loan contingent on the RTC serving as a backstop or guarantor of the back end if toll revenues were not sufficient to cover the debt. The guarantee only includes West side funds. Ultimately this was approved and was precedent setting as the RTC has never been asked to serve as a guarantor. If the RTC is called upon to make good on the guarantee, the first funds would be coming from the federal fund allocation and would be gaining interest at the same rate TxDOT earns.

The item of interest at the regular meeting held on December 12, 2013, was TxDOT wanted the RTC to take the credit risks they signed off on for the I-35W 3A-3B collection bids. The RTC declined to do so. A motion was approved for the RTC not to take the risk. It was recommended to TxDOT if they want to get out of the collection risk, they need to change the way tolls are handled. The annual presentation of the Regional Outer Loop Corridor feasibility study was submitted. There will be a performance measures survey related to incident management sent out by COG (Council of Government) to help remedy issues to reduce time when there is an accident. The survey will be sent out to all fire, police, public safety, public representatives, and city managers.

Commissioner Williams and Judge Self were pleased with the response of the RTC approving the motion to not take on the risk proposed by TxDOT. (Time: 2:03 p.m.)
