3. AI-37042 Negotiation of a scope and fee with HNTB Corporation for engineering services to determine a Right-of-Way footprint for US 75 at the Outer Loop Interchange, Engineering.

Mr. Delgado would like to ask HNTB Corporation to submit a proposal for the cost of a right-of-way footprint regarding power and utility lines, topography, drainage, property owners and transitions on US 75 and the Outer Loop. Since HNTB Corporation was the Project Engineer for the Outer Loop, they already have much of the data.

**EXECUTIVE SESSION**

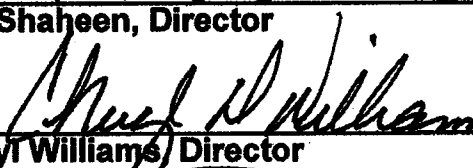
The Board of Directors did not recess into Executive Session. There being no further business of the Board, President Self adjourned the meeting at 2:53 p.m.

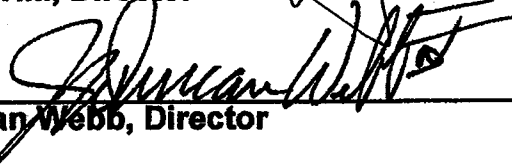
