1. President Self called to order the meeting of the Collin County Health Care Foundation at 8:49 p.m. to address item 2c. The meeting was recessed at 8:59 p.m. and reconvened at 9:56 p.m.

Susan Fletcher, Chairman of the Health Care Advisory Board, came forward and introduced Vice Chairman David Downs. The Advisory Board met on February 21, 2013, and reviewed applications from non-profit agencies. Recommendations were made based on the following services: sick medical visits; laboratory and x-ray services;

prescription drugs; and outpatient medical services. Recipients of services must be residents of Collin County who are U.S. citizens or legal resident aliens with more than 40 working quarters of U.S. employment; and uninsured with household incomes at or below 100% of the federal poverty level.

Mr. Downs announced a total of \$75,663.20 in funding was recommended by the Health Care Advisory Board. The recipients were: Allen Community Outreach, \$22,250; Community Lifeline Center, \$3,000; Frisco Family Services, \$3,250; Health Services of North Texas, \$19,680; and The Samaritan Inn, \$27,483.20. The Advisory Board is also recommending that the remaining unallocated amount of \$44,336.80 be held in contingency if funding needs are identified during the fiscal year.

Following discussion, a motion was made to approve the recommendations of the Health Care Advisory Board. (Time: 8:59 p.m.)

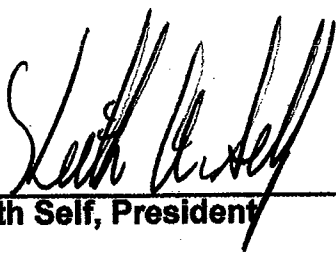

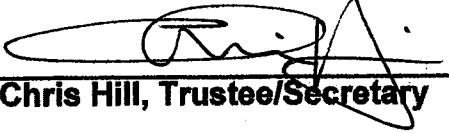
