GENERAL DISCUSSION

5. <u>Al-38041</u> Adoption of an Ordinance regarding Licensing of Junkyards and Automotive Wrecking and Salvage Yards, Development Services.

6. Al-33858 RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb stated that the RTC (Regional Transportation Council) approved and officially adopted the funding for the North Tarrant Express High Occupancy Vehicle Subsidy Project. Funding for the flexible CMAQ (Congestion Mitigation and Air Quality Improvement Program) was also approved. As part of that TxDOT (Texas Department of Transportation) showed interest in purchasing some of the RTC's Transportation Development Credits (TDC). The RTC has authorized the sale of 25-50 million TDCs in exchange for \$5 million in cash. The \$5 million will be used for the "revolver" fund needed to implement the RTC's regional initiatives. The "revolver" fund will allow RTC and NCTCOG to sign and implement federal agreements without having to wait for the upfront city match. When this is done an Interlocal Agreement (ILA) will be made with a city to repay the match to RTC. The approval was made for a resolution supporting the proposed constitutional amendment for transportation funding that will go before the voters in November.

Also, the first reading of the Bylaws came before the RTC. Currently there are 43 members and the Bylaws Committee has recommended an expansion to 44 members. This takes the Allen and McKinney cluster and splits the two resulting in each city having one seat on the RTC. There was discussion related to the recommendation that officer positions be filled with only public officials and how often those positions should rotate between the East and West regions. Currently the rotation is every other year. The Bylaws Committee recommended that officer positions rotate more in line with how RTC disburses revenues in each region; currently it is 69% to the East and 31% to the West. This will come to a vote in April.

Following the RTC update Commissioner Webb gave the audience a brief overview of the RTC. The Federal Government enacted legislation that set forth Metropolitan Planning Organizations (MPO) across the United States. When an area reaches a certain size an MPO can be formed. The NCTCOG (North Central Texas Council of Governments) is the MPO for this area and is made up of sixteen counties. The RTC is a branch of NCTCOG that oversees the metropolitan transportation planning process. The RTC is a 43-person council made up of city and county members. RTC decides how to expend federal and state money for planning and the transportation projects associated with them throughout the region. An example would be the expansion of Central Expressway. All decisions for the expansion were lead through the RTC of the MPO. (Time: 6:10 p.m.)
